# 1916 Valley View Drive Parcel \#6 <br> Right-of-Way 

Whereas, Ken Alan Yarbrough is the owner of land in Craighead County, Arkansas, as described below, and the City of Jonesboro ("the City"), a municipal corporation of the State of Arkansas, is the owner of adjoining land;

Whereas, Ken Alan Yarbrough and the City have agreed upon a right-of-way for construction and maintenance of a street across the land of Ken Alan Yarbrough in favor of the City and in favor of the land of the City.

Now, therefore, be it agreed between Ken Alan Yarbrough and the City on the $\qquad$ day of $\qquad$ 20 $\qquad$ .

1. Ken Alan Yarbrough in consideration of the agreement hereinafter made by city, grants to the City a right-of-way for construction and maintenance of a street over the land of Ken Alan Yarbrough in the City of Jonesboro, Craighead County, Arkansas, or particularly described as follows:

4. This agreement shall insure to and bind the heirs, executors, administrators, successors and assigns of the parties and shall constitute a covenant running with the land of Ken Alan Yarbrough.
