City Attorney Carol Duncan explained this is for one of the retirement plans. She explained it increased the dollar amount of payouts from \$1,000 to \$5,000. She stated it has to do with how payouts will be handled once you are no longer associated with the plan. She further explained if you are terminated, quit or retire there was a certain amount of money they would keep. This would increase the payout from \$1,000 to \$5,000 so the money doesn't have to continue being

managed. This will also give you an out of how to do it if you didn't sign up to do it. City Attorney Duncan noted she thinks that is the main change to the contract, but added it has been a while since she read it.

After adoption of the resolution, questions were asked concerning the ordinance by someone in the audience. Chairman Dover stated he wasn't sure of the answer, but that it would be explained by Chief Financial Officer Ben Barylske when the ordinance is presented to the Council since Mr. Barylske is not in attendance today to explain the ordinance.

City Attorney Duncan stated she referred to the wrong ordinance. This ordinance dealt with the employees hiring an investment advisor. She noted the advisor would be at the employee's expense.

Councilman Burton reminded them it will ultimately be the decision of the voters since it has to go to an election.
