AMENDED ORDER OF CONFIRMATION OF ANNEXATION

On this 4th day of April, 1977, comes on for hearing before the court the above style cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by order of this court dated March 4, 1977. The petitioner appear by and through their attorney, Dennis Zolper. This matter is heard upon the pleadings and orders with exhibits thereto filed herein, the certificate of the Circuit Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said lands and territories herein, from all of which together with other things and matters before the court, and from the evidence presented to the court, the court does find:


That said lands herein were annexed to the City of Jonesboro by order of this court dated March 4, 1977, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas to prevent said annexation within thirty days from date of said order and annexation, and that said annexation was in all things done in conformity with the laws of the State of Arkansas and should therefore be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas; that the lands and territories annexed to the City of

IT IS THEREFORE by the court, considered, ordered, adjudged and decreed that the annexation of said lands and territories herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the proceedings before this court be and are hereby confirmed. The Clerk of this court be and is hereby authorized and directed to certify one copy of the plat of said annexed territory with one copy of this order of the County Court and resolution or ordinance of the City of Jonesboro, Arkansas, and forward copy of each to the Secretary of State who shall file and preserve the same and shall forward one copy of the plat of said annexed territory and one copy of this order to the Director of the Tax Division of the Arkansas Public Service Commission who shall file and preserve the same and shall notify all utility companies having property in said municipality of this annexation of property, and the clerk is directed to forward a certified copy of this order to the City of Jonesboro, Arkansas.
