NOW, THEREFORE, it is agreed that the description of the ENGINEER services and compensation therefore be amended as follows:

1. EXHIBIT A, Scope of Services, shall be modified by Exhibit A.1, Scope of Services along with the associated compensation, attached.



SCOPE OF SERVICES

The ENGINEER will provide all professional services needed to successfully accomplish the following modifications to the Existing Agreement in order to provide the following services:

- I. Additional plats and surveying.
TOTAL LUMP SUM COST.....\$ 5,988.97

- II. Revise Urban Curb & Gutter Section of Lawson Road to a Rural Section without curbs and gutters including revisions to all affected drawings and design.
TOTAL LUMP SUM COST.....\$14,800.00

- III. Revise all impacted plats and legal descriptions along Lawson Road including acquisition and easements.
TOTAL LUMP SUM COST.....\$3,600.00

- IV. Revise Lawson Road Plans to 3 lanes with curb and gutter, 8 foot walkway and bicycle track and plats and descriptions.
TOTAL LUMP SUM COST.....\$16,900.00
TOTAL LUMP SUM REVISION\$41,288.97

The Total Lump Sum Fee is to increase from \$69,940.00 to \$ 111,228.97

- V. Additional surveying to restake acquisition area and easements.
