OBJECTION TO PETITION TO CLOSE ALLEY

1. Donn Mixon, Kathryn W. Mixon, James R. McCauley, and Ruth McCauley are the owners of a lot and building at 505 Union in Jonesboro, Arkansas, which is situated in the Western District of Craighead County, Arkansas, and is described as follows:

Lot 4 in Block "D" of the Original Survey of the City of Jonesboro, Arkansas, the same being part of the Southeast Quarter of the Southwest Quarter of Section 18, Township 14 North, Range 4 East.

- 2. The Mixons and the McCauleys acquired said property by deed and by abandonment of portions of alleys on the north and west sides of the deeded property. Copies of the deed and the two ordinances of abandonment are attached as Exhibits A, B, and C, respectively.
- 3. Craighead County by Roy C. Bearden has petitioned to close an alley which connects the above described property with Madison Street and which is situated in the Western District of Craighead County, Arkansas, and is described as follows:

An alley located south of Washington Avenue and east of Madison Street running east and west in Block "D" of the Original Survey of the City of Jonesboro more particularly described as beginning at the Southwest corner of Lot 10, Block "D"; thence east 130'; thence south 10' thence west 130' to the right of way of Madison Street; thence north 10' along the right of way of Madison Street to the northwest corner of Lot 9, also the point of beginning.

- 4. The Mixons and the McCauleys state that they are the owners of property abutting the alley sought to be closed by the petition of Craighead County by Roy C. Bearden. As abutting property owners, they object to the abandonment of the alley and assert that said abandonment is prohibited by law pursuant to Ark. Code Ann. § 14-301-303 (1987).
- 5. The Mixons and McCauley deny the allegations of the Petition to Close Alley and deny that Craighead County by Roy C. Bearden is the sole owner of all property adjoining the alley described in the petition. As stated above, the Mixons and the McCauleys own property adjoining the alley and they are of the information and belief that other individuals also own property adjoining it.
- 6. The Mixons and the McCauleys assert that their property receives certain utility services from utilities located in the alley proposed to be abandoned. In the event the alley is closed, then no easement would exist for purposes of maintaining these utility services.
- 7. As citizens of Jonesboro, Arkansas, and members of the general public, the Mixons and the McCauleys affirm that the alley in question has been actually used by the public as an alley over the period of the past five years.

WHEREFORE, Donn Mixon, Kathryn W. Mixon, James R. McCauley, and Ruth McCauley pray that the City Council of the City of Jonesboro, Arkansas, deny, reject, and dismiss the petition of Craighead County by Roy C. Bearden to close the alley described in

the petition; and that the Mixons and the McCauleys have all proper legal and equitable relief.

AN ORDINANCE TO VACATE A PORTION OF AN ALLEY

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS:

WHEREAS, A PETITION WAS DULY FILED WITH THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS, ON THE DAY OF APRIL, 1993, TO VACATE AND ABANDON A PORTION OF AN ALLEY DESCRIBED AS FOLLOWS:

A PORTION OF AN ALLEY IN THE ORIGINAL SURVEY TO THE CITY OF JONESBORO, ARKANSAS, AND DESCRIBED AS FOLLOWS: BEGIN AT THE SOUTHWEST CORNER OF LOT 6, BLOCK D; THENCE NORTH APPROXIMATELY 90 FEET TO THE NORTHWEST CORNER OF LOT 4, BLOCK D; THENCE WEST APPROXIMATELY 10 FEET TO THE NORTHEAST CORNER OF LOT 7 OF BLOCK D; THENCE SOUTH APPROXIMATELY 90 FEET TO THE SOUTHEAST CORNER OF LOT 7, BLOCK D; THENCE EAST APPROXIMATELY 10 FEET TO THE SOUTHWEST CORNER OF LOT 6 OF BLOCK D, THE POINT OF BEGINNING PROPER, ALL IN THE ORIGINAL SURVEY TO THE CITY OF JONESBORO, ARKANSAS;

AND

WHEREAS, AFTER DUE NOTICE AS REQUIRED BY LAW, THE COUNCIL HAS, AT THE TIME AND PLACE MENTIONED IN THE NOTICE, HEARD ALL PERSONS DESIRING TO BE HEARD ON THE QUESTION AND HAS ASCERTAINED THAT THE ALLEY OR THE PORTION THEREOF, HEREINBEFORE DESCRIBED, HAS HERETOFORE BEEN DEDICATED TO THE PUBLIC USE AS AN ALLEY HEREIN DESCRIBED; HAS NOT BEEN ACTUALLY USED BY THE PUBLIC GENERALLY FOR A PERIOD OF AT LEAST FIVE (5) YEARS SUBSEQUENT TO THE FILING OF THE PLAT; THAT ALL OWNERS OF THE PROPERTY ABUTTING UPON THE PORTION OF THE ALLEY TO BE VACATED HAVE FILED WITH THE COUNCIL THEIR WRITTEN CONSENT TO SUCH ABANDONMENT; AND THAT THE PUBLIC INTEREST AND WELFARE WILL NOT BE ADVERSELY AFFECTED BY THE ABANDONMENT OF SUCH ALLEY.

SECTION ONE: THE CITY OF JONESBORO, ARKANSAS, HEREBY RELEASES, VACATES AND ABANDONS ALL OF ITS RIGHTS, TOGETHER WITH THE RIGHTS OF THE PUBLIC GENERALLY, IN AND TO A PORTION OF AN ALLEY DESIGNATED AS FOLLOWS:

A PORTION OF AN ALLEY IN THE ORIGINAL SURVEY TO THE CITY OF JONESBORO, ARKANSAS, AND DESCRIBED AS FOLLOWS: BEGIN AT THE SOUTHWEST CORNER OF LOT 6, BLOCK D; THENCE NORTH APPROXIMATELY 90 FEET TO THE NORTHWEST CORNER OF LOT 4, BLOCK D; THENCE WEST APPROXIMATELY 10 FEET TO THE NORTHEAST CORNER OF LOT 7 OF BLOCK D; THENCE SOUTH APPROXIMATELY 90 FEET TO THE SOUTHEAST CORNER OF LOT 7, BLOCK D; THENCE EAST APPROXIMATELY 10 FEET TO THE SOUTHWEST CORNER OF LOT 6 OF BLOCK D, THE POINT OF

ORDINANCE NO. 7/1/40

WHEREAS, as petition was duly filed with the City Council of the City of Jonesboro, Arkansas on the day of the City Council to the City Council to vacate and abandon the alley designated on the plat of Block "D" of the Original Survey to the City of Jonesboro, Arkansas as same appears in Deed Record 1, page 5 of the records in the office of the Circuit CourtoClerk at Jonesboro, Arkansas, designated as follows, "to-wit:

An alley running East and West through the East one-half of Block "D" of the Original Survey of the City of Jonesboro, Arkansas, said alley extending from Union Street on the East to an alley on the West running North and South through said Block "D" of the Original Survey of Jonesboro, Arkansas, said alley running East and West being ten (10) feet in width.

WHEREAS, after due notice as required by law, the City Council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the alley hereinbefore described has heretofore been dedicated to the public use as an alley; has not been actually used by the public generally for a period of at least five (5) years prior to the filing of the petition for abandonment; that all the owners of property abutting the alley to be vacated have filed with the City Council their written consent to such abandonment; and that public interest and welfare will-not be adversely affected by the abandonment of such alley;

NOW, THEREFORE, BE IT ORDAINED by the City Souncil of the City of Jonesboro, Arkansas:

Section 1. The City of Jonesboro, Arkansas hereby releases, vacates and abandons all its rights, together with the rights of the public generally, in and to the alley described as follows:

An alley running East and West through the East one-half of Block "D" of the Original Survey to the City of Jonesboro, Arkansas, said alley extending from Union Street on the East to an alley on the West running North and, South through said Block "D" of the Original Survey of Jonesboro, Abkansas, said alley running East and West ten (10) feet in width.

Section 2. A copy of the ordinance duly certified by the City Clerk shall be filed in the office of the recorder of the County and recorded in the deed records of the County.
