ORD-11:039 AN ORDINANCE TO WAIVE COMPETITIVE BIDDING AND AUTHORIZE ELAVON

TO PERFORM PROFESSIONAL SERVICES FOR COLLECTION OF ALL PAYMENTS MADE TO THE CITY OF JONESBORO BY CREDIT CARDS

City a considerable amount in fees.

ORD-11:040

AN ORDINANCE TO WAIVE COMPETITIVE BIDDING AND AUTHORIZE PURCHASE OF RADIO UPGRADES FOR PUBLIC SAFETY, PUBLIC WORKS AND PARKS INFRASTRUCTURE.

Information Systems Director Erick Woodruff explained after 2012 the current radios will be obsolete and these are the upgrades for those radios. He further explained these radios will also give the departments within the City interoperability in order to communicate with each other. He stated they budgeted for the radios over a two year period, so there will be more radios being ordered next year.

Councilman Fears questioned how much money will be spent on the radios. Mr. Woodruff answered approximately \$36,000 and he will put that in the ordinance before it goes to Council.

Mayor Perrin stated this will also save the City in that cell phones may not be needed in some areas due to the radios, so there will be savings due to the decrease in cell phones.

Councilman Fears then questioned why they needed to waive the competitive bidding. Mr. Woodruff stated Integrated Technologies have already built the system for police and dispatch and are familiar with the City's system. Councilman Fears asked if they are comfortable with the City getting a fair rate. Mr. Woodruff answered yes.

Concern was expressed about the dollar amount not being stated in the ordinance. Mayor Perrin stated they can put the exact cost in the ordinance before it goes to Council.

A motion was made by Councilman Charles Coleman, seconded by Councilman Mikel Fears, that this matter be Recommended to Council with the stipulation of additional information being included in the ordinance to specify price. The motion PASSED by a unanimous vote
