In the interest of clear oversight, strong community engagement, and more efficient coordination across our city's quality of life services I respectfully request that the committee take action to re-establish the Public Services Committee as a standing committee of the City Council and enhance the involvement of the Parks and Recreation Community

Advisory Board so that both bodies actively serve as a structured resource of the Parks and Recreation Departments.
