

CONTRACT FOR SERVICES

AGREEMENT, entered this 1st day of January, 2006 by and between Harry Hardwick and the City of Jonesboro, now whereas: Harry Hardwick is in the business of acquiring property rights and right of ways for street improvements and construction and all other duties as directed by the Mayor, and whereas; the City of Jonesboro is desirous of obtaining such services; KNOW THEREFORE, FOR AND IN CONSIDERATION OF the payment of \$1,000.00 twice monthly for twelve months, Harry Hardwick agrees to acquire the desired right of ways for the City of Jonesboro's MATA Department.

- 1. <u>TERM.</u> This contract shall continue in full force and effect for a period of (12) months from the date subscribed herein, until 12/31/2006.
- 2. <u>PLACE OF PERFORMANCE</u>. This contract shall be performed within the city limits of Jonesboro, Arkansas, at the MATA Departments request.
- 3. <u>AUTHORIZATION</u>. The duly authorized officer of the City of Jonesboro hereto does authorize Harry Hardwick to perform all necessary and requested acquisitions of desire right of way.
- 4. <u>INDEPENDENT CONTRACTOR</u>. The parties hereto do understand and agree that Harry Hardwick is an Independent Contractor not an employee of the City of Jonesboro. That neither party has the right or authority to direct or control the other or agents in the performance of duties and each agrees to indemnify and hold the other harmless for any liability arising from their acts.
- 5. <u>ASSIGNMENT</u>. This contract is only assignable with the written consent of the parties hereto.
- 6. <u>GOVERNING LAW.</u> This contract shall be governed by the Laws of the State of Arkansas.
- 7. <u>TOTAL INCORPORATION</u>. This agreement is the entire agreement between the parties and may only be modified my mutual agreement in writing.
- 8. <u>SAVINGS CLAUSE</u>. This agreement and individual covenants and conditions set forth herein shall be severable. In the event that any provisions shall be held void, illegal or in conflict with applicable State or

Federal Law, the remaining provisions shall remain in full force and effect.

- 9. <u>WITHDRAWAL</u>. Either party may withdraw from the contract at any time, for any reason.
- 10. <u>CONTRACTOR.</u> To furnish personal phone and vehicle, for \$450.00 per month expenses.
