8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

They met with the Highway Department concerning the \$1.9 million the City is looking to spend in 2011. One of the issues is the overpass on Stadium Boulevard. The City asked if a stoplight could be put at the intersection of Parker Road and Stadium. In order to have a stoplight put at that intersection, the intersection will have to be moved south along Stadium about 300 or 400 feet. They are waiting for an approval or decline.

Mayor Perrin announced LM Duncan is the new Operations Director.

He will be meeting with the bond people to see if it would be feasible to take out some sort of bond issue in order to complete some projects. He will be speaking with Crews & Associates as well as Stephens in order to determine whether they City could do a bond issue.

The grants audit by Freeman & Co. is complete. The exit interview will be held and Finance Chair Ann Williams will be attending.

A city auction will be held this Saturday, December 11th, on Strawfloor.

An open house will be held at City Hall on December 14th from 1-4 p.m. He encouraged the citizens to stop by and visit.

They met with ADEQ this morning. The consent administrative order will need to be extended because the cleanup at the landfill is not complete. The letter of extension has been sent and he will be meeting with city staff tomorrow morning in order to formalize a plan of action.

October O&M revenues exceeded expenses by \$225,000. They will be sending the financial reports to the Council members. Street turnback is above 2009, but general turnback is down. He is still encouraged and thinks the City will come in at less than \$1 million in deficit spending for 2010.
