Commission Discussion:

City Planner Otis Spriggs stated that there has been public concern over multiple withdrawals of rezoning cases with no policy set. Mr. Halsey asked what would take to develop a fine for multi-ple withdrawals. Mr. Spriggs suggested that fines be dealt with at a later time.

Mr. Roberts asked what about placing a clause on the 2nd time withdrawal, that you would have to wait 90 days before resubmitting the same or similar petitition. Third-time withdrawals will default to the current ordinance 6 months requirement. Dr. Beadles stated that people have complained that the applicant has hoped to "wear us out, so we will quit coming to the hearings".

Mr. Day asked if we can place a clause for extenuating (emergencies) circumstances where the Commission on request could waive that 90-day restriction on the 2nd time request for withdrawals. Mr. Crego agreed with allowing that clause.

Mr. Spriggs requested that Planning Commission would make recommendation to the Public Works Committee to create a new ordinance

regarding Rezoning Withdrawals in their next meeting with the stipulations that: 1. One withdrawal will be allowed after the 24th of the month; 2. On the 2nd time withdrawal, the applicant must wait 90 days before resubmitting the same or similar peitition; 3. Third-time withdrawals will default to the current ordinance requirement for denied rezoning petitions. Mr. Jerry Halsey made the motion, Mr. Joe Tomlinson seconded the motion. Roll Call Vote: Norris-Aye; Collins- Aye; Tomlinson- Aye; Day- Aye; Halsey- Aye; Dover- Aye; Hoelscher- Aye.

Mr. Crego gave an update on the King's Ranch Court Case. It has been forwared to our attorneys in Little Rock- Mr. Ralph Ohm and Bert Newell. The stated that the answer will be filed and in the mail today (deadline is Thursday).

Dr. Beadles asked for the procedure for district court in terms of judge appointments. Mr. Crego explained the assignment process for substitutes.

Mr. Day asked what is the Commission's responsibility for legal representation. Mr. Crego stated that the City of Jonesboro will assume responsibility for the MAPC and the Council's actions.
