

Attached is a request for the relinquishment of an easement, an alley and an unplatted street associated with the Replat of Jonesboro Real Estate Holdings' Cobb and Lee Survey in Jonesboro. The proposed plan is to abandon these areas to provide for new construction. There are no known telephone facilities in the locations specified. I have no objections to this abandonment provided only the areas indicated are abandoned and the owner or developer assumes responsibility for removal or replacement of any telephone plant found to exist in those easements. The responsible party must initiate a Custom Work Order through the Business Office. Any damage to existing telephone plant, including replacement and repair, will be billable to the responsible party.

A PUBLIC STREET, ALLEYWAY AND DEDICATED EASEMENT

BE IT KNOWN BY THESE PRESENTS that Southwestern Bell Telephone LP, a Texas limited partnership, d.b.a. 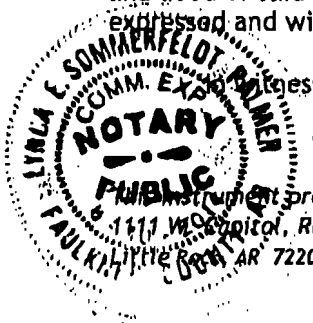
