**CONTRACT FOR SERVICES**

**AGREEMENT**, entered this 15<sup>th</sup> day of November, 2005, by and between **Joe Tomlinson** and the City of Jonesboro, now whereas: **Joe Tomlinson** is knowledgeable and qualified to direct the planning activities of the City of Jonesboro on an interim basis, and whereas; the City of Jonesboro is desirous of obtaining such services; **KNOW THEREFORE, FOR AND IN CONSIDERATION OF** the payment of \$4,8235.88 per month (\$2,411.79 per pay period) for an indefinite interim period to be determined by the Mayor, **Joe Tomlinson** agrees to perform these services at the rate of 40 hours plus per week for the City of Jonesboro's Planning Department.

W-I-T-N-E-S-S-E-T-H

1. **TERM.** This contract shall continue in full force and effect for a period to be determined by the Mayor of the City of Jonesboro.
2. **PLACE OF PERFORMANCE.** This contract shall be performed within the city limits of Jonesboro, Arkansas.
3. **AUTHORIZATION.** The duly authorized officer of the City of Jonesboro hereto does authorize Joe Tomlinson to perform all necessary services in the Planning Department.
4. **INDEPENDENT CONTRACTOR.** The parties hereto do understand and agree that Joe Tomlinson is an Independent Contractor not an employee of the City of Jonesboro. That neither party has the right or authority to direct or control the other or the agents in the performance of duties and each agrees to indemnify and hold the other harmless for any liability arising from their acts.
5. **ASSIGNMENT.** That this contract is only assignable with the written consent of the parties hereto.
6. **GOVERNING LAW.** This contract shall be governed by the Laws of the State of Arkansas.

7. TOTAL INCORPORATION. This agreement is the entire agreement between the parties and may only be modified by mutual agreement in writing.
8. SAVINGS CLAUSE. This agreement and individual covenants and conditions Set forth herein shall be severable. In the event that any provisions shall be held void, illegal or in conflict with applicable State or Federal Law, the remaining provisions shall remain in full force and effect.
9. WITHDRAWAL. Either party may withdraw from the contract at any time, for any reason.
10. CONTRACTOR. Contractor will be provided with a cell phone and use of a City vehicle.
