Chairman Mitch Johnson said, looks like they had a good count of mosquitoes for the month, in the last traps. Looks like they drove 1,193 and a half spray miles for 43,396 acres in the month of July. Jim was going to be in attendance, but he called me this morning and they're flying the plane for the next three nights, here in town as well as another out of town location. I don't know if they'll do us tonight and tomorrow night but we'll be two consecutive nights. They'll fly the north side of the bypass and then the south side, which will be our sprays, five and six. It will leave us with two aerial flights left on our current eight contract for the year. Jim said he felt like the sprays would be adequate to get us through the rest of the season, he felt, at the position we were in. Looks like they're variable to me. Sometimes there worse than

others. I did ask Jim if he had heard anything from ASU or anything like that. He said no one's reached out to him. I don't know if that's something we're going to have to follow up with the mayor on or not.

It has been observed that the building listed above is unsecured, damaged, and/or vacant. **You are hereby directed to board and secure the building within seven (7) days of the receipt of this notice.** The building is to remain secured at all times until the repairs are complete or until such time as the structure is razed and removed.

If you decide to abate this nuisance, you must obtain any necessary permits. All damaged or missing doors and/or windows must be repaired, replaced, or boarded up to prevent entry. All boarding material shall be cut to fit the opening to be secured, weatherproofed, and painted and maintained to blend with the exterior color of the building. Damaged roofs shall be tarped to prevent further weather damage to the interior of the building. **All repairs are to be made and all boarding materials and tarps are to be removed within six (6) months.**

In the event you have not commenced work to secure the building within seven (7) days from the receipt of this notice, the City will take actions required to abate the nuisance. All costs of abatement will be billed to you as owner of the property. Payment of this bill will be actively pursued. A tax lien will be placed on the property until payment is received in full. **A fine of not less than \$100 shall be imposed and an additional fine of \$100 for each day thereafter. (Ord. 19:061)**

Boarding and securing the structure does not relieve the owner of the requirement to diligently repair, rehabilitate or demolish and remove the structure.

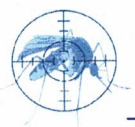
Vector Disease Control, Inc. (VDCI) provides a proven, scientific approach to mosquito control for the city of Jonesboro. VDCI's operations include larval and adult mosquito surveillance followed by the application of larvicides and adulticides. In addition, our office responds to **(41)** service requests from the public.

Mosquito Surveillance

VDCI has utilized a total of thirteen **(13)** New Jersey light traps placed in residential and recreational areas throughout Jonesboro during this reporting period. These traps collected an average of **31.4125** mosquitoes per trap night **(1655)** total mosquitoes) during this time. There have been a total of **1** mosquito species collected.

Larval Control Activity

Permanent water, flood water, artificial containers, and drainage system sites are inspected for larval mosquito breeding on a regular basis. In total, **38** sites inspected with **12** sites having mosquito larvae present. As a result of these inspections **327** ounces of the larvicide VetoBac G was applied to these mosquito breeding sites. Additionally, VDCI is continuing to eliminate breeding habitats for artificial container mosquitoes by targeting bird baths, buckets, tires, etc.



ADULT MOSQUITO CONTROL ACTIVITY

In response to community events and mosquito surveillance data, VDCI applied adulticide (**30**) truck routes for this reporting period. All adulticide ULV applications were made with truck-mounted ULV units equipped with GPS-enabled monitors. During this report period, a total of **1,150.30** spray miles (**41,824.90** acres) were treated with a total of **277.80** gallons of adulticide in residential and recreational areas.

Summary

During this reporting period, VDCI has continued to provide exceptional control of larval and adult mosquito populations. VDCI will remain diligent in our surveillance and control activities to prevent a significant increase in the mosquito population. Based on recent weather conditions VDCI expects the trend of routine adulticiding and larviciding to continue. However, if VDCI detects a significant rise in the mosquito population we will increase larval and adult control. 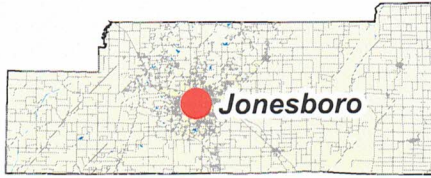

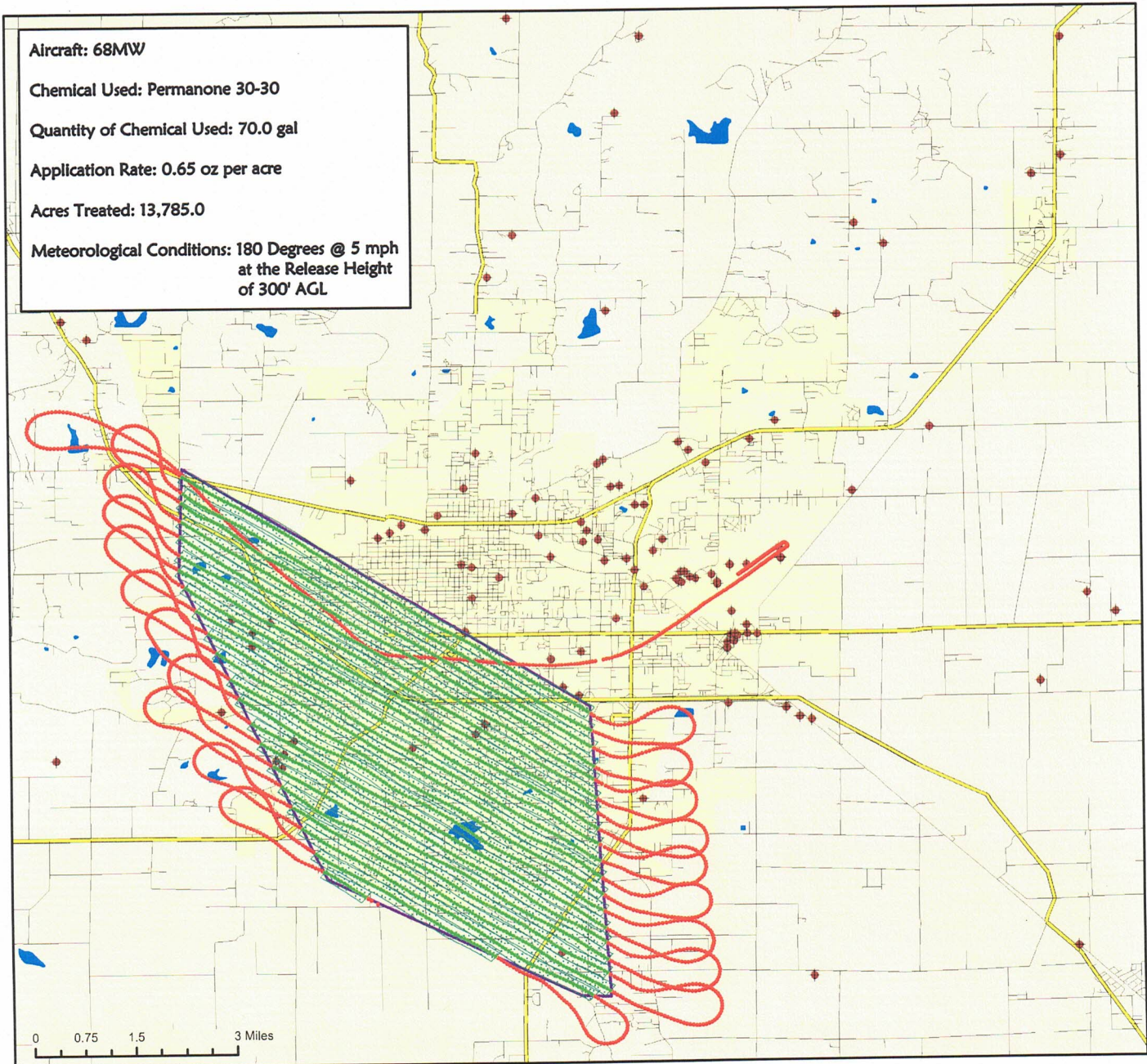
