ORDINANCE NO. 2134

AN ORDINANCE TO VACATE A FIFTEEN FOOT ALLEY RUNNING NORTH AND SOUTH BETWEEN ALLEN AND GORDON STREETS. BEING BOUNDED ON THE WEST BY LABAUME AND ON THE EAST BY MILLER STREET.

BE IN ORDAINED BY THE CITY CONCIL FOR THE CITY OF JONESBORO, AR.

WHEREAS, A PETITION WAS DULY FILED WITH THE CITY COUNCIL FOR THE CITY OF JONESBORO, AR ON THE 5TH DAY OF JULY, 1988, TO VACATE AND ABANDON A 15 FOOT ALLEY RUNNING NORTH AND SOUTH BETWEEN ALLEN AND GORDON STREETS. BEING BOUNDED ON THE WEST BY LABAUME AND ON THE EAST BY MILLER STREET, WHICH PLAT IS RECORDED IN DEED RECORD48 AT PAGE 1/6 OF THE RECORDS OF THE JONESBORD DISTRICT OF CRAIGHEAD COUNTY, AR.

WHEREAS, AFTER DUE NOTICE AS REQUIRED BY LAW, THE COUNCIL HAS, AT THE TIME AND PLACE MENTIONED IN THE NOTICE, HEARD ALL PERSONS DESIRING TO BE HEARD ON THE QUESTION AND HAS ASCERTAINED THAT THE STREET OR THE PORTION THEREOF, HEREINBEFORE DESCRIBED HAS HERETOFORE BEEN DEDICATED TO THE PUBLIC USE AS A STREET HEREIN DESCRIBED; HAS NOT BEEN ACTUALLY USED BY THE PUBLIC GENERALLY FOR A PERIOD OF AT LEAST FIVE (5) YEARS SUBSEQUENT TO THE FILING OF THE PLAT; THAT ALL OWNERS OF THE PROPERTY ABUTTING UPON THE PORTION OF THE STREET TO BE VACATED HAVE FILED WITH THE COUNCIL THEIR WRITTEN CONSCENT TO SUCH ABANDONMENT: AND THAT PUBLIC INTEREST AND WELFARE WILL NOT BE ADVERSELY AFFECTED BY THE ABANDONMENT OF SUCH STREET.

SECTION ONE: THE CITY OF JONESBORO, AR, HEREBY RELEASES, VACATES AND ABANDONS ALL OF ITS RIGHTS, TOGETHER WITH THE RIGHTS OF THE PUBLIC GENERALLY. IN AND TO THE STREETS DESIGNATED AS FOLLOWS:

A 15 FOOT ALLEY RUNNING NORTH AND SOUTH BETWEEN ALLEN AND LABAUME STREETS. BEING BOUNDED ON THE WEST BY LABAUME AND ON THE EAST BY MILLER STREET. THUS PROPERTY IS SUBJECT TO DRAINAGE EASEMENTS.

SECTION TWO: A COPY OF THE ORDINANCE DULY CERTIFIED BY THE CITY CLERK SHALL BE FILED IN THE OFFICE OF THE RECORDER OF THE COUNTY AND RECORDED IN THE DEED RECORDS OF THE COUNTY.

SECTION THREE: THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND APPROVAL.
