I have appraised the above property as of October 12, 2000, and find the market value to be \$57,695. In accordance with your instructions, I have reduced the lot size by the "amount of taking" for the purpose of widening Flint Ave. The remaining value is \$54,355 or a difference of \$3340 which is the just compensation due the owner. In addition, a temporary easement fee of \$150 is being paid bringing total compensation to \$3,490.

The purpose of this appraisal is to give a fair market value of the land taken by the City of Jonesboro for the expansion of Flint Street. The subject at 1400 Flint will lose a tract of land: 667.78 sq ft

The value of the improvements has not been affected. Therefore, the tax assessed value of \$34,230 has not been used in the appraisal. The appraiser is only adding the land value. The set back may affect the parking lot and the entrance to the improvements.

DEFINITION OF MARKET VALUE: The most probable price which a property should bring in a competitive and open market under all conditions requisite to a fair sale, the buyer and seller, each acting prudently, knowledgeably and assuming the price is not affected by undue stimulus. 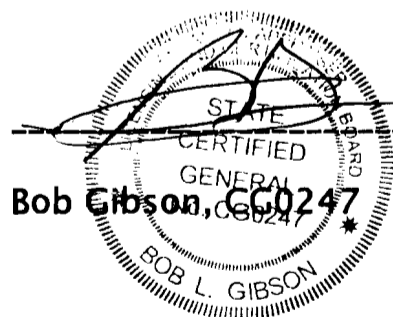
