REAL ESTATE LEASE AMENDMENT

THENCE: North 89 degrees 55 minutes 25 seconds West for a distance of 290.40 feet to a point;

THENCE: North 00 degrees 14 minutes 00 seconds East for a distance of 150.00 feet to the POINT OF BEGINNING.
