Police Chief Michael Yates explained he has been working on the ordinance for about a year and have met with people in the downtown area regarding the code. Councilman Perrin questioned whether there were any changes from the last version Chief Yates provided to the committee. Chief Yates stated it is exactly the same since the last meeting. Discussion was held concerning the code. Councilman Perrin expressed concern over the length of time the code allows dumpsters in the road. He stated the dumpsters should not be allowed to sit too long. Chief Yates explained he would like to put the ordinance in place and in a year or six months from now go back and make changes as needed. Councilwoman Furr stated she's okay with approving the ordinance, but asked that any revisions are done quickly.

5. Other Business

Police Department: Chairman Moore questioned whether they would be expanding the number of motorcycles. Chief Yates stated they are finding new uses for the motorcycles and are thinking of asking for more in the next budget.

Mayor Formon discussed alternative ways to put in pedestrian and bicycle paths on city streets that he recently heard about at the MPO meeting in Little Rock. He suggested trying to put a bicycle path on Huntington since it was just re-paved and hasn't been striped yet.

Chief Yates informed the committee there is a resolution to enter into a contract with Sterling Solutions that was not on the agenda. He explained Mr. Crego approved the first version of the resolution, but they had to change the name from "Michigan" to "Arkansas" in the contract. City Clerk Donna Jackson stated Mr. Crego did not approve the second version of the resolution in order for it to be put on the agenda. Chief Yates stated Mr. Crego did approve it this afternoon. Ms. Jackson questioned whether it had been approved the second time because if it had been approved then it would've been put on the agenda. Chief Yates stated the resolution is under a timeline because the person they're entering into a contract with has a long waiting list. He discussed the contract and work that would be done. He added the resolution needs to go through Public Safety and on to the City Council under New Business. Councilwoman Furr suggested to adjourn and reconvene when Mr. Crego arrives for the Council meeting. It was later decided not to reconvene the meeting because it was discovered the approval process for the second version of the resolution had not been started, so it had not been sent to the Mayor's Office or to Mr. Crego's office.

6. Public Comments

Ms. Michelle Eaton questioned the status of her request to change the City Code to allow her to keep her pot-bellied pig, Rutty. Chairman Moore stated there has been no progress that he knows of. He added unless a member of the committee makes a motion to change the code then the code will stay as it is. Councilman McCall questioned whether Ms. Eaton found any information regarding pot-bellied pigs being allowed in other cities in Arkansas. Ms. Eaton explained she found nothing for the state of Arkansas. Chairman Moore stated he didn't see anything in the information Ms. Eaton provided the committee that warranted a change. Mayor Formon stated he discussed the situation with other city's at the recent Municipal League Conference. He explained the City of Jacksonville mayor indicated they changed their ordinances to ban pot-bellied pigs. Ms. Eaton stated if the ordinance isn't changed to disallow pot-bellied pigs, then the City could possibly be in the same situation in the future.
