#### 8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

Total cost of the public works facility is \$6,259,000, which is under the budget of \$6,737,000. He thanked Councilman Vance for his work on the facility.

The City has been working on nuisance abatement for about a year. There are 47 current abatements. He thanked the City Attorney's Office and the Police Department for their work.

The YMCA building is structurally sound, so they will do some minor improvements. He will come up with recommendations and present them to the Building Facilities Committee in the next few weeks.

They will be holding a luncheon on Thursday, September 6, at the public works facility on Dan Avenue. Several contractors were invited to discuss the Miracle League Field. He hopes the contractors will be willing to provide labor and/or materials for the field.

He, along with Chief Financial Officer Ben Barylske and Grants Administrator Heather Clements, will be visiting Washington D.C. from September 12th through September 14th. Meetings have been established concerning federal grants. They will be meeting with the Assistant Secretary of Transportation where the Mayor will present him with material from the Highway Commission meeting next week concerning the work needed in Jonesboro.

He discussed appointing Councilman Coleman to the Housing Authority with the executive director, Sharon Poe, as requested by the City Council at the last meeting. Ms. Poe informed him state law says no one from the governing body can serve on JURHA. He sent Ms. Poe a letter asking for another appointment since the City Council rejected Mr. Jackson's appointment.
