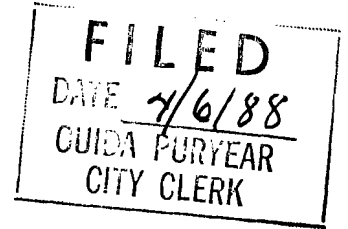


TO THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS

PETITION TO VACATE AND ABANDON STREETS AND ALLEYS

Come the undersigned Petitioners, and for their Petition,
state:

1. Petitioners own all the land which abuts 3rd, 4th, 5th and
6th Streets between Johnson Avenue and Word Street and the alleys
running North and South and/or East and West in Blocks 5, 6, 7, 8 &
9 of Barritts (Barretts) Addition to the City of Jonesboro.

2. Said streets and alleys have been dedicated as public
streets and alleys to the City of Jonesboro, Arkansas, but are not
needed for highway purposes and the welfare of the City will be
enhanced or promoted by the abandonment of said streets and
alleys.


3. Petitioners request that the City of Jonesboro by and
through its City Council abandon and vacate 3rd, 4th, 5th and 6th
Streets between Johnson Avenue and Word Street and the alleys
running North and South and/or East and West in Blocks 5, 6, 7, 8 &

Arkansas.

direct the City Clerk to give notice by publication once a week for
two weeks in the Jonesboro Sun advising property owners who might
be affected that on a day certain the City Council for the City of
Jonesboro will hear this Petition and determine whether such public
streets and alleys should be abandoned and vacated.

Code Annotated Title 14-301-301-306 and 14-54-104.
