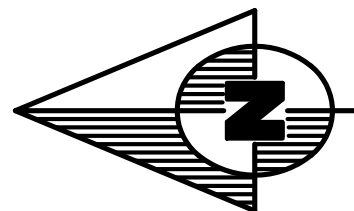

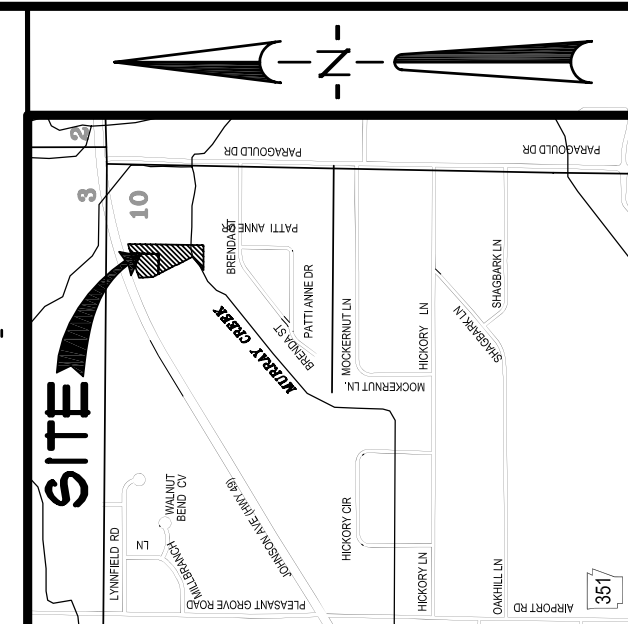
BEARING BASIS
