### **RIGHT-OF-WAY**

Whereas, **Joe Ed Brooks**, and city have agreed upon a right-of-way for construction and maintenance of a street across the land of **Joe Ed Brooks**, in favor of city and in favor of the land of the city;

Now, Therefore, be it agreed between **Joe Ed Brooks**, and city on this **277** day of **CCTO** RER. 2004.
