ORDER OF CONFIRMATION OF ANNEXATION

On this 11th day of July, 1977, comes on for hearing before the Court the above styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by Order of this Court dated June 6, 1977. The Petitioners appear by and through their attorneys, Seay & Bristow. 
