## 8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

The bids for the Mercantile Center renovation were opened today. The low bid was \$2,593,000 with a few close bids. They will review the bids and get back with the Council.

On December 15th an auction will be held regarding the buildings at the old landfill. The buildings have been cleaned out and are ready to be sold. There will be two buildings left on Strawfloor. They will install a fence after the buildings are sold.

He will be attending a Highway Commission meeting in Little Rock next week. He will also be meeting with Sandra Ott.

He announced the retirement of MPO Director Amin Ulkarim. Accounts Payable Specialist Brenda Sharp will also be retiring after 31 years of service. They will hold a retirement party at the end of December.

He received a letter from the Arkansas State Police regarding the AWINs tower at the Services Center. They will be making arrangements to move the tower to Strawfloor.

Winter Wonderland will open on Saturday, November 24. It will be open from 1:00 p.m. to 8:30 p.m. on Saturdays and 5:30 p.m. to 8:30 p.m. Monday through Friday. He sent letters to local schools in order to bring students.

He presented the Council with the proposed 2013. He will answer questions, along with Chief Financial Officer Ben Barylske. There will be surplus in O&M, but there will be a deficit in Capital Improvements. This will equal out to a \$560,000 surplus in 2013. They have done the 2013 budget revenue blind. It is not a deficit spending budget, but does have a tight surplus. Discussion was held concerning the rebate checks. Mr. Barylske stated they have been trying to plan how much the rebates will be for big projects such as the new NEA Hospital and Jonesboro High School so they can estimate how much of the sales tax revenue will be affected. Councilman Vance explained the rebates apply to project invoices above \$2,500. Councilman Moore noted that the NEA Hospital project could result in thousands of rebates due to the number of invoices. Mr. Barylske agreed, adding that is why they were conservative when they prepared the budget because it is hard to estimate the amount of rebates.

He wished everyone a happy Thanksgiving.

### 9. CITY COUNCIL REPORTS

Councilman Street also wished everyone a happy Thanksgiving.

Councilman Johnson thanked the voters for voting him to another term. He stated he is looking forward to another four years.

Councilman Moore thanked everyone for their support during his re-election and congratulated Councilmen Johnson and Fears on their re-election.

Councilman Coleman thanked Chief Operating Officer LM Duncan for his work with the light on Carson, but he pointed out the reflectors in the sidewalk aren't easily seen. He also thanked the City and the State for the work on the bridge on Bridge Street. He added once the lights are finished it will look better. He noted the bridge is safer than it was before. Mayor Perrin added they have a company that is willing to

donate the lights for the bridge. They will be meeting with the company next Monday. He noted he is hoping to have the project done by Christmas.

Councilman Vance wished everyone a happy Thanksgiving.

Councilman Frierson thanked the Mayor, Mr. Barylske and the Finance staff for the Legislative Audit. He stated this is a remarkable, clean audit. Mayor Perrin thanked Councilman Frierson for recognizing the audit and that it's one of the cleanest audits this City has had.
