# 8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

He's asked all department heads to give him a list of anticipated projects for 2014. At the February 4th meeting, they will present a PowerPoint presentation detailing all of the capital improvement projects that are budgeted for this year. It will name the projects, detail what will be involved and the timeline for the project.

The Municipal League's Winter Conference will be held in Rogers this year from January 29-31.

He sent a letter to the county judge to propose the MAPC meet twice a month. This will reduce time for developers to wait for necessary documentation. It will also give the committee more time to look at each project. Most of the cities they have recently visited with have MAPC's that meet twice a month. He is going to ask them to amend their bylaws so they can start meeting twice a month in February.

Sanitation Director Royce Leonard has retired. They have received over 75 applications for the position. They are interviewing applicants and will keep the Council up to date on the progress. He hopes to have a decision made by February 1

The Nominating & Rules Committee will be made up of the Council members from Wards 4, 5 and 6 this year. After they schedule their first meeting, he would like to visit with the committee concerning the stipulation in the Code of Ordinances that says a chairman can only vote if there is a tie. He would like to revise that in order to allow a chairman to vote in other instances.

He was informed earlier this week that he has been appointed to the National League of Cities Steering Committee. They will discuss general finance programs and other financing issues. He will be attending a meeting on March 9th.

# 9. CITY COUNCIL REPORTS

Councilman Street announced the Public Works Committee will hold a special meeting on Monday, January 13, from 5:30 p.m. to 6:30 p.m. to discuss the proposed access management ordinance. He stated it is available online and encouraged everyone to look at it and give them feedback.

Councilman Vance asked for the capital improvements project PowerPoint presentation that the Mayor referred to during his Mayor's Report be posted to Legistar as soon as possible in order for people to be able to view it. This will allow them to ask any questions they may have.

# 10. PUBLIC COMMENTS

Mr. Pat Alston approached the podium to discuss an issue with the City Council, but declined to speak.

Mr. David McAlvoy, 731 W. Matthews, thanked Councilman Coleman for his work to get a street in Jonesboro named after Dr. Martin Luther King, Jr. He stated he knew there was opposition to the renaming of North Church, so if the renaming doesn't occur on that street that it should happen with another street or a new street. He explained this is the City's chance to do something very important.

Mr. Chris Gambill, 1713 N. Church, spoke in opposition to the renaming of North Church to Dr. Martin Luther King Jr. Blvd. He noted that he may be charged for changing the address of his property and questioned who would pay for those charges.

Mr. George Baxley, a resident on North Church, also spoke in opposition to the renaming of North Church to Dr. Martin Luther King Blvd. He encouraged the Council to look at naming a new street or the bypass after Dr. Martin Luther King as opposed to an existing street due to the work it would put on the property owners to change addresses. He expressed concern over the inconvenience and cost of changing the street name.
