


01-000-0502-00	Electric Permits	The YTD 2009 Electrical permits total 597, with a total revenue of \$8,227. This is down approximately \$5000 or 57% from YTD 2008. YTD 2008 permit totals were 840, with a total revenue of \$13,962. There was a decline of 243 permits, or 29%, from YTD 2008 to 2009. We believe this is due to the slow down in the economy.
01-000-0503-00	Plumbing Permits	The YTD 2009 Plumbing permits total 573, with a total revenue of \$8,227. This is down approximately \$2,293 or 21 % from YTD 2008. YTD 2008 permit totals were 705, with a total revenue of \$10,520. There was a decline of 132 permits, or 19%, from YTD 2008 to 2009. We believe this is due to the slow down in the economy.
01-000-0504-00	Building Permits	The YTD 2009 Building permits total 249, with a total revenue of \$49,202. This is down approximately \$15,071 or 23 % from YTD 2008. YTD 2008 permit totals were 284, with a total revenue of \$64,273. There was a decline of 35 permits, or 12%, from YTD 2008 to 2009. We believe this is due to the slow down in the economy.






