AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF JONESBORO, ARKANSAS AND FOR OTHER PURPOSES

Whereas, a petition was filed with the County Court of Craighead County, Arkansas, pursuant to A.C.A. § 14-40-602, for the annexation of certain territory into the City of Jonesboro, Arkansas; and

Whereas, on February 17, 2023, the County Court of Craighead County, Arkansas found that the Petition was signed by the majority of the real estate owners in said territory; that said territory was depicted on an accurate map of said territory, filed with and made a part of the Petition, showing the property to be contiguous and adjoining the present corporate limits of the City of Jonesboro, Arkansas; that proper notice had been given for the time and in the manner prescribed by law, and in all things pertaining thereto had been done in a manner prescribed by law, and that said land and territory should be annexed to and made a part of the City of Jonesboro, Arkansas, subject to the acceptance of same by the City Council of Jonesboro at the proper time as provided by law; and

Whereas, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order; and

Whereas, it is the desire of the City of Jonesboro that said territory be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS:

Section 1: That the following described territory, contiguous to the City of Jonesboro, Arkansas, be and the same hereby accepted as part of, and annexed to and made part of the City of Jonesboro, Arkansas:

Part of the Southeast Quarter of the Southeast Quarter of Section 33, Township 15 North, Range 4 East, Craighead County, Arkansas, more particularly described as follows: Commence at the East Quarter Corner of said Section 33, thence South $00^{\circ}17'20"$ East 1531.0 feet to the point of beginning; thence continue South $00^{\circ}17'20"$ East 402.92 feet; thence North $88^{\circ}39'37"$ West 113.78 feet to the East right-of-way of State Highway No. 351; thence North $01^{\circ}18'37"$ East along said right-of-way 402.76 feet; thence South $88^{\circ}39'37"$ East 102.52 feet to the point of beginning, containing 1.0 acre, more or less. Subject to assessments, building lines, easements, mineral reservations and/or conveyances, restrictions, and any other matters of record or fact.

Section 2: That the following schedule of services shall be extended to the area by the City of Jonesboro after the date of annexation becomes final:

- (1) Police Services;
- (2) Fire protection services;
- (3) Residential solid waste disposal services;
- (4) City planning and code enforcement services; and
- (5) Street and storm water system maintenance on city streets and drainage easements.

Section 3: That the above-described territory shall be annexed to and made a part of Ward 3 of the City of Jonesboro, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 4: That thirty days after the passage and publication or posting of this Ordinance as authorized by law, the annexation shall be final and the property shall be within the corporate limits of the City of Jonesboro, Arkansas.

Section 5: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 6: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

ORDER APPROVING ANNEXATION OF CERTAIN LANDS COUNTY & PROBATE COURT CLERK INTO THE CITY OF JONESBORO, ARKANSAS

On this 17th day of February, 2023, the Petition for Approval to Annex Certain Lands into the City of Jonesboro, Arkansas (the "Petition") filed by James Turner and Brandy Turner was presented to the Craighead County Court (the "Court"). The Court finds as follows:

1. The Petition was filed on January 13, 2023 by James and Brandy Turner asking that the following lands located in Craighead County, Arkansas be annexed into the City of Jonesboro, Arkansas (the "Real Property"):

Part of the Southeast Quarter of the Southeast Quarter of Section 33, Township 15 North, Range 4 East, Craighead County, Arkansas, more particularly described as follows: Commence at the East Quarter Corner of said Section 33, thence South 00°17'20" East 1531.0 feet to the point of beginning; thence continue South 00°17'20" Esat 402.92 feet; thence North 88°39'37" West 113.78 feet to the East right-of-way of State Highway No. 351; thence North 01°18'37" East along said right-of-way 402.76 feet; thence South 88°39'37" East 102.52 feet to the point of beginning, containing 1.0 acre, more or less. Subject to assessments, building lines, easements, mineral reservations and/or conveyances, restrictions, and any other matters of record or fact.

- 2. This matter was set for public hearing on February 17, 2023.
- 3. On February 14, 2023, James and Brandy Turner filed in the Court a Proof of Publication, showing that notice of the hearing was published in *The Jonesboro Sun*, a newspaper of general circulation in Craighead County, once a week for three weeks prior to the hearing. The Court finds that the notice and publication thereof satisfy the requirements of A.C.A. 14-40-602.
- 4. At the hearing, all interested persons were provided an opportunity to speak for or against the Petition and the relief requested therein.

5. After hearing all evidence for an against the Petition, the Court finds that the relief requested in the Petition should be granted, and the annexation of the Real Property described above into the City of Jonesboro should be approved.

IT IS THEREFORE, CONSIDERED, ORDERED AND ADJUDGED that the Petition is granted and the Real Property described above shall be considered annexed into the City of Jonesboro, Arkansas upon its acceptance thereof by proper ordinance. This Order shall be recorded by the County Clerk.

PETITION FOR APPROVAL TO ANNEX CERTAIN LANDS INTO THE CITY OF JONESBORO, ARKANSAS

James Turner and Brandy Turner, by their attorney, Gramling Law Firm, PLC, petition this Court to approve the annexation of the lands described below in Craighead County, Arkansas, into the city limits of the City of Jonesboro, Arkansas, and states as follows:

1. James and Brandy Turner are the owners of the following described real property located in Craighead County, Arkansas (the "Real Property"):

Part of the Southeast Quarter of the Southeast Quarter of Section 33, Township 15 North, Range 4 East, Craighead County, Arkansas, more particularly described as follows: Commence at the East Quarter Corner of said Section 33, thence South 00°17'20" East 1531.0 feet to the point of beginning; thence continue South 00°17'20" Esat 402.92 feet; thence North 88°39'37" West 113.78 feet to the East right-of-way of State Highway No. 351; thence North 01°18'37" East along said right-of-way 402.76 feet; thence South 88°39'37" East 102.52 feet to the point of beginning, containing 1.0 acre, more or less. Subject to assessments, building lines, easements, mineral reservations and/or conveyances, restrictions, and any other matters of record or fact.

- 2. The Real Property is depicted in an Annexation Plat conducted and prepared by M² Surveying and a true and correct copy of that plat is attached hereto as Exhibit A.
- 3. The Turners petition this Court to annex the Real Estate into the City of Jonesboro to protect his family and home.
 - 4. This annexation is unique, and corrects part of a cutout in the current City Limits.
- 5. Due to the great proximity to the city limits of Jonesboro, Arkansas, the highest and best use of the Real Property is realized within the city limits of Jonesboro, Arkansas.

6. The Turners request that this Court set a date for public hearing on this petition, to be conducted not less than thirty (30) days from the date of the filing of this petition pursuant to A.C.A. § 14-40-602.

7. Upon the date of the hearing being set, the Turners shall cause notice of the hearing to be published in the *Jonesboro Sun* one (1) time per week for three (3) consecutive weeks before the hearing.

8. The Turners respectfully request that the Craighead County Court approve the annexation of the Real Property into the City of Jonesboro and request an Order granting its petition.

9. Petitioner has coordinated this application with the Arkansas Geographic Information Systems office, and a duplicate of the coordination materials is attached to this petition as Exhibit B.





A RESOLUTION BY THE CITY OF JONESBORO TO ENTER INTO AN INDEMNIFICATION AGREEMENT WITH CIRCA 1859, INC., d/b/a THE DOWNTOWN JONESBORO ALLIANCE (DJA)

WHEREAS, DJA wishes to install string lights in the City right of way; and,

WHEREAS, the City of Jonesboro wishes to enter into an agreement with DJA to indemnify the City of Jonesboro from and against any and all claims against the City of Jonesboro for any damages as a result of the installation of string lights in the City right of way on Main Street from Cate/Burke to Washington.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1. The City of Jonesboro shall enter into an agreement with DJA. to indemnify the City of Jonesboro from and against any claims against the City of Jonesboro for any damages resulting from the strings lights being placed in the City right of way on Main Street from Cate/Burke to Washington.

Section 2. The Mayor and City Clerk are hereby authorized by the City Council for the City of Jonesboro to execute all documents necessary to effectuate this agreement.

INDEMNIFICATION AGREEMENT

Now comes Circa 1859, Inc., d/b/a the Downtown Jonesboro Alliance ("DJA"), who agrees to indemnify the City of Jonesboro (the "City") from and against any and all claims against the City from any damages resulting from the STYNO LIGHTS being placed in the City right of way on Main Street from CITY BUYFE to WOSNINGTON.
The String light installed herein shall be maintained by the DJA and any subsequent business owners until such time that the improvements are no longer needed and have been permanently removed to the City's satisfaction.
The City may remove the improvements at any time if said improvements are not being adequately maintained, or at any other time it is determined to be necessary, and the DJA and/or any subsequent owner shall receive no compensation for such removal. However, the City shall promptly return the property to the DJA in the condition it was in immediately prior to its removal.
The City of Jonesboro shall not be responsible for the improvements or any damages to the improvements caused by itself or any third party.
This Indemnification Agreement shall not waive, limit, or otherwise affect any defenses or immunity that the City and/or the DJA may have against any claims covered by this Agreement, including, but not limited to, any defense of governmental or charitable immunity. Furthermore, this Agreement shall not constitute an admission of liability on the part of the City or the DJA. The DJA shall have the right to participate in the defense of any claim or suit, and the City shall cooperate with the DJA in such defense. A RESOLUTION BY THE JONESBORO CITY COUNCIL DECLARING AN EXCEPTIONAL SITUATION AND WAIVE COMPETITIVE BIDDING TO REPAIR DAMAGE TO CITY-OWNED INDUSTRIAL TRACK

WHEREAS, Eastside Rice LLC damaged the City-Owned industrial track on March 18, 2023;

WHEREAS, Shelby Railroad Services, Inc., the on-call contractor for rail services, accessed the damages and the cost to mobilize and repair the damaged rail to be \$34,343.00;

WHEREAS, Eastside Rice LLC has agreed to reimburse the City of Jonesboro all expenses related to repairing the damaged rail; and,

WHEREAS, bidding is impractical due to nature of the damage and the immediate need to repair the damaged rail.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1: An exceptional situation exists requiring the waiving of the conditions of competitive bidding, so that competitive bidding requirements are hereby waived, and Shelby Railroad Services, Inc. was mobilized to repair damages to City-Owned industrial track.

Section 2: Eastside Rice LLC has acknowledged the damages and will reimburse the City of Jonesboro all expenses related to repairing the damages that resulted from the March 18, 2023 accident.
