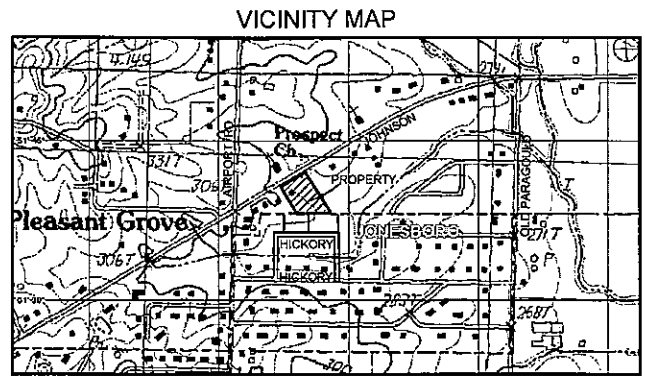

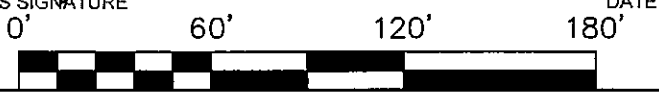


EXISTING R-1 REQUEST C-3

PART OF THE NW 1/4 OF THE NE 1/4 OF SECTION 10, T14N-R4E, CRAIGHEAD COUNTY, ARKANSAS, MORE PARTICULARLY DESCRIBED AS FOLLOWS; COMMENCE AT THE SW CORNER OF THE NW 1/4 OF THE NE 1/4 OF SAID SECTION 10; THENCE N 88°55'00" E 605.30 FEET TO A 1-1/4" PIPE ALSO THE POINT OF BEGINNING; THENCE N 31°08'00" W 268.20 FEET TO 1/2" REBAR WITH A RED CAP (HAMMAN, AR 1273) SAID POINT BEING ON THE SOUTH RIGHT-OF-WAY OF STATE HIGHWAY #49 (EAST JOHNSON AVE.); THENCE N 57°24'00" E ALONG SAID RIGHT-OF-WAY 248.10 FEET TO A 1/2" REBAR WITH A YELLOW CAP (ADAMSON, AR 1065); THENCE S 32°04'00" E 422.10 FEET TO A 1-1/4" PIPE ON THE SOUTH LINE OF THE NW 1/4 OF THE NE 1/4 SECTION 10; THENCE S 88°55'00" W ALONG SAID SOUTH QUARTER LINE 294.50 FEET TO THE POINT OF BEGINNING, CONTAINING 1.99 ACRES, MORE OR LESS, AND BEING SUBJECT TO A 10.0 FOOT UTILITY EASEMENT DEEDED TO CITY WATER AND LIGHT ON THE 28TH DAY OF APRIL, 1988 AND RECORDED IN DEED BOOK 359 PAGES 386-387 ON MAY 6, 1988.
