Concerning the above referenced street right-of-way abandonment, CWL will require a forty (40) foot 69 Kv electric easement, twenty (20) feet either side of our line, as constructed. CWL will also require a twenty (20) foot sewer easement, ten (10) feet either side of our line, as constructed.
