CITY OF JONESBORO, ARKANSAS

O R D E R

On this 3rd day of August, 1970, come H. E. Eldridge and Lillian Scott Eldridge by Archer Wheatley, their agent, and present their Petition for the annexation to the City of Jonesboro of lands described as follows:

Beginning at a point where the South line of right of way of State Highway Number 1 intersects the West line of Northwest Quarter of Section 16, Township 14 North, Range 4 East, thence East to East line of right of way of Caraway Road for beginning proper; thence Easterly along South right of way line of Highway Number 1 300 feet, thence South 150 feet; thence Westerly and parallel with South right of way line of said State Highway Number 1, 300 feet more or less to point 150 feet South of beginning point proper above described, thence North 150 feet to point of beginning.

The Court finds that said Petitioners are the owners of said land; that on the 30th day of June, 1970, they filed in this Court their Petition that said land be annexed to the City of Jonesboro and naming Archer Wheatley as their agent to act in their behalf; the Court fixed the 3rd day of August, 1970, as the time for the hearing of said Petition; that Notice of the filing of said Petition and the time for the hearing thereof was duly published in the Jonesboro Sun, a daily newspaper published and having a general circulation in Craighead County, once a week for three consecutive weeks.

The Court further finds that the allegations of the Petition are sustained by the proof that said Petitioners are the sole owners of said land; that the limits of the territory to be annexed have been accurately described and an accurate map thereof made and filed. The said land is adjacent to the City of Jonesboro and the prayer of the Petitioners is right and proper. No objections or protests to same have been made by anyone.

IT IS, THEREFORE, BY THE COURT CONSIDERED, ORDERED  
AND ADJUDGED that the territory above described be and the  
same is hereby annexed to the City of Jonesboro.
