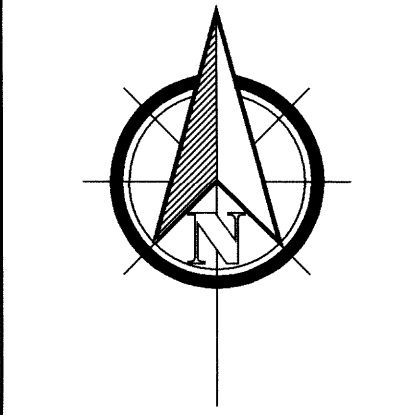

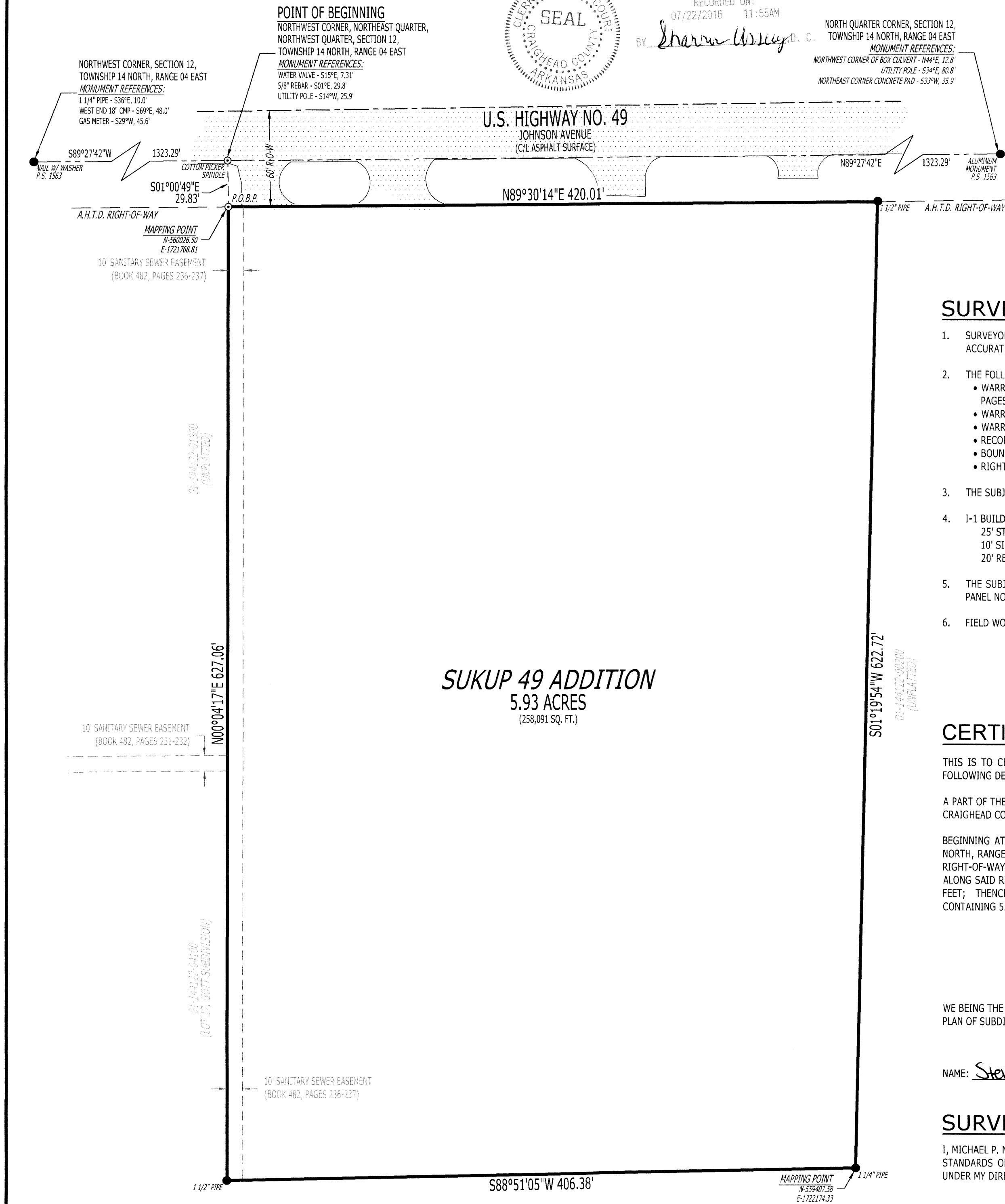


VICINITY MAP

BEARINGS BASED ON ARKANSAS STATE PLANE GRID NORTH ZONE (0301)

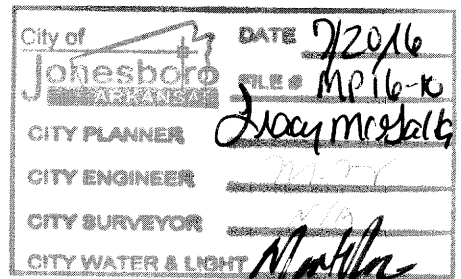
