Presentation by City Clerk Donna Jackson regarding Legistar and Municode

**Sponsors:** City Clerk

*Ms. Jackson demonstrated the Municode website that has the City's Code of Ordinances. She explained the website lists recent ordinances passed by Council that change the code book. She further explained this allows the City to amend the code book once a year, instead of twice, which will cut costs. She noted this will also allow the code book to constantly stay up to date. Presentation by Mrs. Sherry Beatty from the Foundation of Arts

**Sponsors:** Mayor's Office

*Ms. Beatty discussed the Foundation of Arts. She explained they are a non-profit organization that offers quality, family-oriented arts programming for northeast Arkansas and southeast Missouri. She further explained they offer programs in*

community theater, arts education and outreach services. She discussed the Foundation of Arts and the impact of arts education on the citizens. She stated the Foundation of Arts holds five theatrical shows per year with 35 to 40 performances per year. She added last year the five shows attracted more than 8,000 people from all over the country. Ms. Beatty stated 4,000 students come in from districts all over north Arkansas. Their arts education department teaches about 200 classes per year with over 1,100 enrolled in 2009. She then discussed their community outreach services. She explained they are assisted financially by CDBG, donations and partnerships. She continued discussing the Foundation of Arts.

## **8. MAYOR'S REPORTS**

*Mayor Perrin gave the following report:*

*He gave the Council the new format for the financial reports. He discussed the new format and noted the budget reflects the O&M account being \$1.3 million under budget. He added more expenses will be coming up through the rest of the year.*

*Governor Beebe and Colonel Phillip from the Arkansas State Police attended a press conference with the Jonesboro Police Department concerning internet crime concerning children. City & Town Magazine recently had a story in it concerning the Police Department's new website.*

*The electricity is being set up for the incinerator. Within a week or two, burning should begin.*

*Bids were taken on several pieces of property. Those bids were taken to the Building Committee and they rejected all of the bids. The committee will get appraisals on some of the parcels and possibly taken more bids that have minimum and maximum amounts.*

*A meeting was recently held with the District Engineer for the Highway Department. They discussed a double left-hand turn lane from Stadium onto Johnson. The City has received permission for the double left-hand turn lane, but due to the cost it will be done in 2011. They also discussed a right-hand turn lane on Parker Road at the intersection with Caraway. It will be striped tomorrow.*

*The Highway Department will be cleaning out the drainage boxes along the bypass.*

*He will be attending the Highway Commission meeting in Little Rock tomorrow. He*

*will be taking proposals down there. One is concerning the bypass exit at Stadium near Phillips Drive, possibly putting in a curve to join southbound Stadium so drivers will not need to make a left-hand turn onto Stadium anymore.*

*Information has been received from two cities in Florida who withdrew their money from their Principal pension plans. Human Resources Director Gloria Roark will be sending the form out to all retirees for them to sign and return in order to transfer the funds.*

*This Thursday will begin another round of public meetings to discuss the sales tax. The meetings will be held every Thursday in June at 6:30 p.m. in City Council Chambers. They have already spoken with the Lion's Club and plan to meet at the Senior Centers.*
