ORDER OF ANNEXATION

On the 5th day of March, 1990, comes on for hearing before the Court the petition for annexation of certain lands to the City of Jonesboro, Arkansas filed in this Court on January 30, 1990. The cause is heard upon the petition, notice of filing of said petition and of the date, time and place of hearing thereon and the proof of publication of such notice as required by law and the evidence introduced by witnesses, argument of counsel and all other matters and things before the Court, from all of which the Court finds:

1. That the petition filed herein is signed by a majority of the real estate owners requesting to be annexed, and this majority of the total number of owners own more than one-half of the acreage involved.

2. That the limits of the territory to be annexed have been accurately described and an accurate map thereof made and filed herein.

3. That the notice of the filing of said petition and the date, time and place of this hearing upon said petition has been duly given and published as required by law.

4. That all things required by law to be done have been duly and properly done and the allegations of the petition are sustained by proof.

It is therefore by the Court CONSIDERED AND ORDERED that the petition herein be, and it is hereby granted and all of the lands and territory herein described be, and they are hereby annexed to the City of Jonesboro, Arkansas, said lands and territory so annexed to the City of Jonesboro, Arkansas being more particularly described as follows:

Begin at the NW corner of the SW 1/4, SW 1/4 of Section 18, T14N, R5E; thence east 300' to the point of beginning proper; thence east along the south quarter section line of Section 18 to the northeast corner of the SW 1/4, SW 1/4 of Section 18; thence south along the west quarter section line of Section 18 to the southeast corner of the SW 1/4, SW 1/4 of Section 18; thence continue south along the west quarter section of Section 19, T14N, R5E to the northwest corner of the SE 1/4, SW 1/4 of Section 19; thence east along the south quarter section lines of Sections 19, 20 and 21 to the northwest corner of the SW 1/4, SW 1/4 of Section 22, T14N, R5E; thence continue east along the south quarter section line of Section 22, 300'; thence south along a line running 300' parallel to the west section line of Section 22 to a point 300' north of the south section line of Section 22; thence west 300' along a line running 300' parallel to the south section line of Section 22 to the west section line of Section 22; thence continue west along a line running 300' parallel to the south section lines of Sections 21, 20, and 19 to a point 300' east of the west section line of Section 19; thence north along a line running 300' parallel to the west section line of Section 19 to the south section line of Section 18; thence continue north along a line running 300' parallel to the west section line of Section 18 to the point of beginning proper, all located in Craighead County, Arkansas and containing some 505.55 acres, more or less.

Be it further ORDERED that the said lands and territory shall be deemed and taken to be a part of the limits of the City of Jonesboro, Arkansas and the inhabitants residing therein shall have and enjoy all of the rights and privileges of the inhabitants within the original limits of the City of Jonesboro, Arkansas, upon said lands and territories being accepted by ordinance of the City Council of the City of Jonesboro, Arkansas.
