Chief Building Inspector Terry Adams stated Inspections and Code Enforcement are back under the same department. He discussed the departments.

Councilman Hargis questioned whether Inspections handles sidewalks. Mr. Adams answered no, that falls under the Engineering Department. He explained Inspections takes care of buildings and houses from the ground to completion to make sure all codes are met.

Mayor Perrin stated the City met with Legacy Landfill to discuss a composte facility at their facility. He explained they are looking at feasibility and some City employees are looking at other composte facilities in the state. He further explained they appointed five members of their Board to work with the City on the project. He stated the project could cost \$1.5 million. He noted City Engineer Craig Light has contacted ADEQ to let them know about the yard waste stacked at the City's facility.

After a short recess, Mayor Perrin noted on ORD-09:032 there were two abstentions so he voted in order to waive the third reading.

Mayor Perrin stated the DFIRM map went out on time and they are waiting on FEMA's answer.

Mayor Perrin explained sidewalk construction will start tomorrow by Hillcrest and they will go down Wilkins. He further explained after they receive the additional funding from HUD they will proceed with more projects.

Mayor Perrin stated there are 30 tornado sirens up with only three left to put up. He added D&J has started chipping the ice storm debris. He explained the City has paid D&J \$1,238,571. He noted Mr. Tony Thomas and Public Works Director Erick Woodruff are working with FEMA in order for the City to start getting reimbursed.

Mayor Perrin explained the fleet maintenance software is in and will be implemented in the Police Department. He stated after working with the software it will be implemented in the rest of the City. He added they will be taking bids for cell phone service and data lines. He asked for comments regarding the proposed computer policy.

Councilman Moore discussed a previous proposal to hire a company to look at sales tax revenue. He stated the quicker the City can review it, then the further back the City can look. Mayor Perrin explained at the next Council meeting they should have something ready.
