ORDER OF CONFIRMATION OF ANNEXATION

On this 11 day of March, 1975, comes on for hearing before the court the above styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by order of this court dated February 4, 1975. The petitioners appear by and through their attorneys, Parker & Henry. The matter is heard upon the pleadings and orders with exhibits thereto filed herein, the affidavit and certificate of the Circuit Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said lands and the territory herein, from all of which together with other things and matters before the court, the court doth find:

That said lands herein were annexed to the City of Jonesboro by order of this court dated February 4, 1975, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent said annexation within thirty days from date of said order and annexation, and that said annexation was in all things done in conformity with the laws and Statutes of the State of Arkansas, and should therefore be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas.

That the lands and territory annexed to the City of Jonesboro, Arkansas, are described as follows, to wit:



The Northeast Quarter of the Northeast Quarter of Section 35, Township 14 North, Range 3 East; the Northwest Quarter of the Northwest Quarter and the North 17 acres of the Southwest Quarter of the Northwest Quarter, all in Section 36, Township 14 North, Range 3 East (INCLUDING LOT 1 IN BLOCK A, LOTS 1, 2, and 3 IN BLOCK B, LOTS 1, 2, 3, 4, 5, and 6 IN BLOCK D, AND LOT 1, BLOCK E, OF CANDLEWOOD ESTATES FIRST ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, AS SHOWN BY PLAT IN DEED RECORD 198 PAGE 20, SUBJECT TO BILL OF ASSURANCE IN DEED RECORD 216 PAGE 100, AND TO EASEMENTS AS SHOWN ON RECORDED PLAT). All property is located in the Jonesboro District of Craighead County, Arkansas.

IT IS THEREFORE, BY THE COURT, CONSIDERED, ORDERED, ADJUDGED AND DECREED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the proceedings before this court be and are hereby confirmed. The Clerk of this court be and is hereby authorized and directed to certify one copy of the plat of such annexed territory with one copy of this order of the County Court and resolution or ordinance of the City of Jonesboro, Arkansas, and forward copy of each to the Secretary of State who shall file and preserve the same and shall forward one copy of the plat of said annexed territory and one copy of this order to the Director of the Tax Division of the Arkansas Public Service Commission who shall file and preserve the same, and shall notify all utility companies having property in said municipality of this annexation of property, and the Clerk is directed to forward a certified copy of this order to the City of Jonesboro, Arkansas.
