AGREEMENT

This agreement is entered into by and between Jonesboro Special School District No. 1 of Craighead County, Arkansas, hereinafter referred to as "School District," and City of Jonesboro, Arkansas, hereinafter referred to as "City."

- 1. City and School District have agreed upon a proposal for construction of a detention area at the northwest corner of School District's High School Campus. School District has executed, contemporaneously with this agreement, a drainage easement to City on certain property described in the easement, a copy of which is attached to this agreement as Exhibit "A". This easement is being given now to facilitate the work described on the plat attached to Exhibit "A" and further outlined below.
- 2. In consideration of the granting of the easement from School District to City, City agrees that it will pay for the following services to be done near or upon the property described in the easement:
