Mayor Perrin limited each side to five minutes of discussion due to the ordinance being only on second reading. He noted the ordinance will be on third reading at the next meeting.

Engineer Terry Bare of Haywood, Kenward, Bare & Assoc., discussed the rezoning. Mr. Bare explained they use the Code of Ordinances and the Land Use Plan when designing and developing in their business. He noted his clients are asking for a duplex development, which is less dense than apartments. He discussed the surrounding properties and further explained this is a transitional plan and would benefit the area.

Mr. Todd Burton, 4303 Cypress Springs Road, spoke in opposition to the rezoning. He expressed concern that this rezoning could set a precedence for the City and asked the Council to vote against it. He noted it does not follow the long-term Land Use Map. He added the existence of high density zoning is not an excuse to continue with more high density zoning in residential areas.

Mr. Mickey Bridger also spoke in opposition to the rezoning. He the Council to consider how their neighbors would feel if this rezoning was in their areas. He stated they have people from five different subdivisions in attendance tonight. He explained this rezoning has been denied by MAPC and the City Council before.

This item was Held at second reading.

Attorney Charles Mooney, Sr. discussed the rezoning. He noted the MAPC has recommended rezoning the property. This property is located next to the old landfill

and there is no way the property would be used for R-1. It has been up for sale for three years and no one has shown interest in the property. They would like to rezone the property in order to develop it as rental property. They propose 24 duplex units being built there and is in the best interest of the City and the people who own the property.

Mr. Frank Trent, 1013 Sandino Drive, spoke in opposition to the rezoning. He expressed concern over the development being so close to a condemned landfill. He noted it may be a good place for a park. He stated the only people who are in favor of the rezoning are the ones who will profit from it. He explained the development will add to the traffic and crime problems in this area. He further discussed his concerns. He suggested the developers search for a better place for their development.

Mr. Chris Winberry, 1005 Sandino Drive, also spoke in opposition to the rezoning. He noted Greensboro Road is narrow. He also noted there are numerous apartment complexes south of this property that need to be torn down. He expressed concern over anything low-income being built in this area for fear that it will have the same problems as the nearby apartment complexes. He recommended taking care of problem areas that already exist.

Ms. Susan Trent, 1013 Sandino Drive, stated her opposition to the rezoning.

Councilman Frierson motioned to adopt the ordinance. The motion failed for lack of a second.

Councilman Moore explained City Attorney Phillip Crego informed him it would be better to have a motion voted down than to have a motion fail for lack of a second.

A motion was made by Councilman Chris Moore, seconded by Councilman Mitch Johnson, that this matter be Passed . The motion FAILED by the following vote:
