Councilmember David McClain commented that he thought that there was only one way in and one way out of Bettie Drive. Are there other streets that I am not seeing? I am not the best at looking at these sometimes. Is there something that I don't see? Planning Director Derrel Smith stated that there should be two ways in and I believe the connection to the north for future development. Mr. McClain said, okay. Which way is in right now. Mr. Smith said, right now you go in on French Street and Bettie Drive.

Don Overton commented, I represent the applicant. If you will look on the map, it's color coded and easy to read. You can see French is at the bottom which connects to Alpine, over to Church. Bettie is on the Master Street Plan for the City of Jonesboro as a collector. Eventually, that is going to connect Church to Culberhouse. We have negotiated with the city and we are going to dedicate 10-feet of that. When that collector donation was originally done by the development to the north they only gave 60-feet. So, we are giving another 10-feet making a total of 70-feet there for that collector, the easement, that way the city has room to put that collector in. We are going to continue Bettie over past the curve on French. This is only a schematic design, it's not the completed design. We have worked with Planning and Engineering over the last 7 to 8 months on this. So, that will be our main in and out. If you look on the east, there is a 36-ft. wide ingress/egress easement that is listed on there as well. We are in negotiations with the two property owners that abut that. They actually offered it to us that they would be interested in discussing with us purchasing that. I am still waiting to hear back from them. They said it would be sometime in the middle of this month before they got back with me because of the holidays. We are hopeful that will be a third entrance but right now we have the two entrances which should be more than enough. There is also a traffic study that we have included in the packet

that we commissioned to have done. The level of service is currently a B. It is all in that report. The essence of the report is that the current level of service is a B. That level of service is based upon the time it takes when you come to that intersection on Church Street from either Bettie or Alpine, how long it takes when you pull up to that intersection before you can turn. So, currently, it is a B. After we put in the projected number of units that we have on there, it is still going to be a B. So, in the grand scheme of things, according to the traffic study, the level of service is not going to be impacted by the numbers going in utilizing those two streets. Obviously, if we are able to secure that third entrance, then those would go drastically down. But, as it is currently and the city can verify that, the level of service that it shows and the conclusion will not go from a B to a C. And, my understanding, is that the City of Jonesboro doesn't require any change or improvements unless something comes up to a D. So, we are far below the level of traffic that would impact that and the city can expand on that more.

Mr. Smith said, he is correct about it being a B. Normally, if it was a highway job or a city job, a lot of times you design for a level service of D. So, this is quite a bit better than most of the intersections in the city. Councilmember Chris Moore asked, if upon passage, a rezoning on this, it would still go back to the MAPC for a final site plan approval. Mr. Smith said, that is correct. They will have to come back through with the preliminary plat and everything. They have provided a pattern book. We will make sure that it follows all of that.

study done there. When we did our signal timing plans we did some traffic counts and internal studies of that intersection, and it was included in our improvement plan back we when asked for a sales tax several years ago. I believe that it is still on the unfunded asking list. Councilmember Moore commented that there is an active rail spur in that area as well.
