Councilperson Chris Moore introduced the ordinance for first reading by Title Only.

Attorney Matt Modolesky representing Gene and Dorothy Hanes spoke in opposition to the zoning change. He explained the Pines Apartments and the Hanes' property is located across the street from the proposed rezoning. He explained historically the area has had flooding problems, and currently are in litigation with the City of Jonesboro. Attorney Modolesky stated they had concerns rather than objections that the addition of apartments would complicate the current drainage problems. He stated to date there has not been any remedy proposed or adopted to correct the flooding issues. Mr. Modolesky requested the flooding of the Pines Apartments and the Hanes' property be corrected first before any rezoning is considered and adopted. Mr. Kelly Panneck, City Engineer addressed the Council saying City Engineering does not review until development plans have been submitted. He stated at the request of Ms. Betty Shaw he looked at the area and it does appear to be two separate drainage basins separated by Caraway Road. Mr. Panneck stated they have addressed the drainage problems at the Pines Apartments with the creation of a detention basin design with Miller Newell having completed 70 % of the plan. Mr. John Easley, Engineer for the zoning project explained there were two separate basins, and thier basin is located on the east side of Caraway Road containing

70 acres. He explained they were in compliance with Storm Water Regulations and were controlling their own runoff with onsite detention at the south end of the property. Mr. Easley explained they would be working with the drainage at the back end of Subway as part of the Storm Water Compliance. Mr. Panneck explained based on his review and Mr. Easley's review Caraway Road separates the two basins, just before coming together at Subway's Restaurant, which is below the Pine's Apartments. Attorney Modolesky requested the zoning matter be delayed.

A motion was made by Councilperson Ann Williams, seconded by Councilperson Harold Perrin, that this matter be Placed on second reading. The motion CARRIED.

Mayor Formon provided GMP Estimates and Bid Recap Letters regarding the Animal Control Shelter and Fire Stations 7 and 3. He explained Adam was available to answer any questions they may have. Councilman Moore reported as result of meeting with ADEQ the City has been given formal approval to use a clay cap instead of a synthetic liner. He explained the low bidder was Cameron Construction. He explained the contract would be submitted to the Public Works Committee in two weeks with a possible recommendation to the full Council. He further explained there would also need to be a motion to request Attorney Andy Adams to discontinue an appeal of the original synthetic liner. Councilman Moore explained this saved the City of Jonesboro approximately \$800,000.00. over the original cost.
