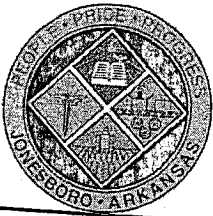

BE IT ORDAINED by the City Council for the City of Jonesboro, Arkansas that:

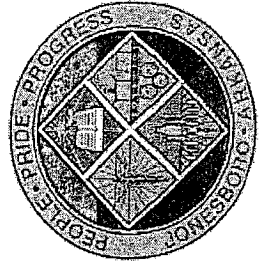

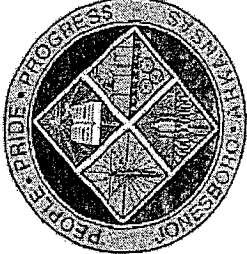
