

## Sec. 28.-21. Residential districts

Here is the information that I sent to Mr. Baker at Liberty Bank regarding Watersprings ranch zoning questions.

The Watersprings Ranch area was annexed by Ordinance K-209 on October 20, 1986. It was zoned R-1 at the same meeting.

Here is a brief description:

(1) *R-1 rural residential district.* This is a district for single-family homes on large rural lots or acreage, and also provides an area where selected agricultural uses can be accommodated. It is a zone that is generally applied to fringe areas of the city, and such areas may, over time, be converted to higher density residential areas.
