Mayor Perrin explained he has someone to hire for the Chief Financial Officer position, but according to the City salary plan he is authorized to only offer up to halfway between the minimum and midpoint salary for the pay grade. He further explained he would like to offer more than the halfway point. He apologized for not including the information in the ordinance that was recently passed concerning the CFO position.

Councilman Hargis questioned what the person who is being considered for the position is making at his current job. Mayor Perrin answered he doesn't know, but he thinks it's not far below what he has offered the candidate. Councilman Hargis expressed concern over the person who is being considered for the position coming from Legislative Audit and is someone who has previously audited the City's finances.
