Fire Marshal Craig Davenport explained all over the state novelty lighters are starting to be banned because they have caused several child deaths and injuries. Chairman Moore questioned whether the City has the right to ban a product that is legally made available. Mr. Davenport stated he thinks so because several other cities have banned novelty lighters, including North Little Rock. He noted Polk County has banned novelty lighters county-wide due to a fire caused by novelty lighters in September that killed three children in Russellville. Chairman Moore then questioned how novelty lighters are defined in comparison to regular lighters. Mr. Davenport explained it goes by the US Consumer Product Safety Commission. Chairman Moore then noted the ordinance describes novelty lighters. Discussion was held regarding whether the ordinance should be added to the

Council agenda or wait until the next meeting. It was decided to wait until the next meeting to put the ordinance on the agenda in order to give sellers time to pull the lighters from their stock. Mr. Davenport added the ordinance notes lighters that are stored in warehouses are not subject to the ordinance.

5. Other Business

Usage of Parking Fund money

Lt. Roger Morphis explained they found an ordinance from 1959 that establishes the Parking Authority and the parking meter fund used to pay off bonds from improvement of downtown parking. He further explained City Attorney Phillip Crego recommended drafting a new ordinance to specify how the money will be used. Police Chief Michael Yates stated the impression he's gotten is that the money should go towards parking enforcement and improving the parking areas. Councilman McCall discussed a recent e-mail from Kent Arnold questioning downtown parking and improvements. Chief Yates stated they could use the funds for improvements if it's specified that's what the funds are to be used for. Chairman Moore recommended using the money for capital improvements and policing personnel.

Councilman McCall questioned the status of the lot on Cate that doesn't have any lighting. Chief Yates explained there is existing lighting but it's not operable. Councilman Perrin suggested getting with CWL to work on getting lighting.

Councilman Hargis explained the fund's money was derived from double-taxation from the downtown properties for about 15-20 years which helped with that improvement district. He stated he thinks the property homeowners should have some strong input as to the improvements.
