THAT City of Jonesboro, Arkansas, GRANTOR, pursuant to the abandonment of a portion of Tumbleweed Street, pursuant to Ordinance No. 2573, adopted August 15, 1994 by the City Council of the City of Jonesboro, Arkansas, hereby grants, and conveys unto Ronald Lee Bowen and Sherry Anne Bowen, his wife, GRANTEES, all of GRANTOR'S right and interest in the following described property in the City of Jonesboro, Craighead County, Arkansas to-wit:

The unimproved east end of Tumbleweed Street more particularly described as: Begin at the northwest corner of lot 14 of Upper Duckswater Addition, first revision to the City of Jonesboro, Arkansas; thence south  $34^{\circ}31'34''$  west along the east line of said lot 14, 303.84 feet to the existing right-of-way line of Tumbleweed Street, the point of beginning proper; thence along the right-of-way line, aforesaid, along a  $159^{\circ}11'57''$  curve to the right with a radius of 60.00 feet, a distance of 166.73 feet; thence north  $13^{\circ}43'31''$  east 10.18 feet; thence along a  $108^{\circ}50'10''$  curve to the left with a radius of 50.00 feet, a distance of 94.98 feet; thence north  $34^{\circ}31'34''$  east 27.20 feet to the point of beginning proper, containing 0.0808 acres.
