Honorable Mayor Perrin and City Council Members: My name is Tom Reeves, a resident of Jonesboro. I appreciate the opportunity to speak to you this evening.

My comments tonight will **strongly oppose** the United Nations **Agenda 21 and Jonesboro Vision 2030** (which I will call "2030" henceforth) **to the extent it implements Agenda 21**. Agenda 21 has been called “The Death Knell of Liberty and Freedom.” “The **Biggest Fraud in the History of the Planet Earth.** Agenda 21 is being implemented over a long period of time, gradually, secretly, deceptively, so the U.S. population does not realize what is happening to them. The U.N. has created a “**U.S. Death Map**,” which they plan to enforce. The **inescapable conclusion**: the U.N. has invaded the U.S. and is in total military control of the U.S. Otherwise their “U.S. Death Map” could not be enforced.

If and when **Agenda 21’s maximum world 100 Million population¹ goals are fully implemented only 953 persons from Jonesboro, 41,765 people from the State of Arkansas and 4,463,787 people out of the total U.S. population will survive. 85.8% to 98.6% of the world’s population MUST die to meet the U.N.’s goals – that is 6 to 7 Billion people, 1,000 Million, if you will. Even if 1 Billion people are allowed to survive worldwide, only 9,526 Jonesboro, 417,647 Arkansas and 44,637,869 U.S. citizens will survive. Will you or your children and grandchildren be one of them? Probably not.**

To give you an **indication of how stupid and outrageously radical** the U.N. and the EPA are, the **U.N. recently implemented two petitions**: (1) asking for support to reduce the U.S. gross domestic product by 6% because the U.S. failed to support the Kyoto Protocol and (2) asking for support to ban water because it is a component of acid rain.²

In the U.S., without scientific basis the **EPA attempted to implement regulations limiting the amount and type of dust** farmers can raise while tilling their acreage. I suppose, since the U.N. opposes Christianity, they intend to levy fines against God, or Christians, for raising wind-blown dust. Thank God for the Bi-Partisan “Farm Dust Regulation Prevention Act of 2011” prohibiting the EPA from doing that.³ The EPA doesn’t call it dust; deceptively it’s “particulate matter.” H.R. Bill 875, the FDA Food Safety Modernization Act, read literally, makes it **illegal for an individual to grow a garden** to produce food for personal consumption.⁴

The U.S. media irresponsibly chooses to ignore Agenda 21 opposition, so the U.S. population remains ignorant of its provisions, or even its existence.

The **State of Alabama** drew worldwide attention to U.N. Agenda 21 when their legislature, House and Senate, voted unanimously to approve Senate Bill SB 477, the **first official state ban of Agenda 21 implementation.**⁵

Foreign Press praised Alabama as “The State(s) that Saved the World.”⁶ Arizona (and Wisconsin) had a similar bill before their state legislature, but their legislative session ended before the bill was approved. Expect to see Arizona’s bill again during their next legislative session.

I AM NOT ALONE IN MY CONCERN ABOUT AGENDA 21.

“United Nations’ Agenda 21 policy” deems America’s national sovereignty a social injustice and concludes ‘the only way to make the future environment sustainable is to reduce America’s living standards and transfer their wealth to developing nations’.”⁷ *Why not the living standards of the rest of the world?*

The **National Republican Party has been the forerunner** in opposition to Agenda 21⁸ and its local versions.  5. **Discard all bias towards Agenda 21 implementation** from all communications to Jonesboro citizens; view and **disclose both sides** of the argument for and against **honestly and objectively**;
 6. **Communicate** to Jonesboro's citizens the intent of 2030 AND THE COST, MONETARY AND OTHERWISE;
 7. **Discard the advice of outside advisers who have no vested interest** in Jonesboro's future;
 8. **Disregard the influence of radical environmentalists**, no matter from whence they come; they do not have Jonesboro's or its citizens' best interests in the forefront of their minds; **PREVENT SUPPRESSION OF COMMENTS OPPOSING AGENDA 21 AT ALL COSTS**; You **MUST** hear, and listen to, opposing comments;

11. **Adopt resolutions or regulations that oppose and ban Agenda 21 for the City of Jonesboro and its surrounding metropolitan areas;**
12. Honestly and thoroughly **educate Jonesboro's citizens** and then **give them the opportunity to vote** on a topic that could so drastically change their lives for the worse. Don't implement a set of unrealistic, unwanted and unsupported plans upon our citizenship that will bring their wrath down upon you. Life is far too short for that kind of grief.

Taxpayers suffer immensely; taxpayers are not an endless supply of finances. Somewhere there is a breaking point and we, as a nation, are very near it.

The top 2% pay 38% of U.S. Federal Income Taxes; the top 10% pay 71% of Income Taxes.¹⁸ When the top 10% of taxpayers start exiting the U.S., and their wealth gives them that capability, the U.S. will have a problem of monumental proportions on our hands and U.N. invasion will become a certainty.

Kissell, D-N.C. The bill would prohibit the EPA “from burdening farmers and small business owners in rural America with additional dust regulations.”

“Regulation of farm dust by the EPA could severely hamper the ability of farmers in Virginia and across the nation, and has the potentially devastating effect of decreased productivity, increased food prices and lost jobs in the rural economy,” said the Virginia Farm Bureau Federation’s Wilmer Stoneman. “In addition, there is no scientific basis for establishing such a regulation and we doubt that the benefits would outweigh the costs.”
