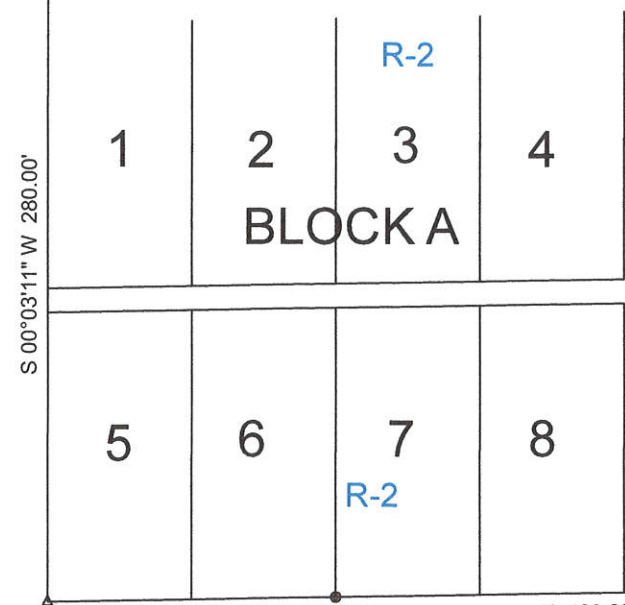

DONALD STREET

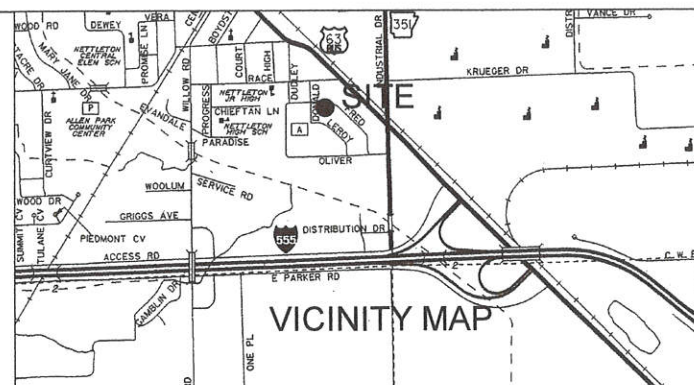

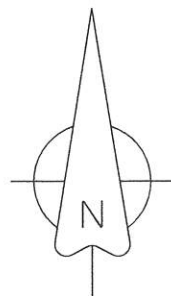


VICINITY MAP

DESCRIPTION:

thence North 00°03'11" East 120.00 feet; thence North 89°07'21" East 166.26 feet; thence South 43°13'41" East 134.37 feet; thence South 46°29'50" West 130.83 feet; thence North 65°24'16" West 157.89 feet; thence South 89°07'21" West 19.93 feet to the point of beginning proper, having an area of 33541.27 square feet, 0.77 acres more or less and being subject to all public and private roads and easements.
