ORDER OF CONFIRMATION OF ANNEXATION

On this day of April, 1979, comes on for hearing before the court the above styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by order of this court dated March 12, 1979, and filed March 13, 1979. The petitioners appear by and through their attorneys, McDaniel & Gott, P.A. The matter is heard upon the pleadings and orders with exhibits hereto filed herein, the affidavit and certificate of the Circuit Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent the annexation of said lands and the territory herein, from all of which together with other things and matters before the court, the court doth find:

That said lands herein were annexed to the City of Jonesboro by order of this court dated March 12, 1979, and were filed March 13, 1979, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent said annexation within thirty (30) days from data of said order and that said annexation was in all things done in conformity with the laws and statutes of the State of Arkansas, and should therefore be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas.

That the lands and territory annexed to the City of Jonesboro, Arkansas, are described as follows, to wit::

Fegure 12 Not the Section line 211.24 to the westerly R/W line of U.S. Highway No. 49; thence Southwesterly along said R/W line along a 3° 32' curve to the left 296.4'; thence N81° 02' W along said R/W line 20.0'; thence S8° 58'W along said R/W line 74.2'; thence N 81° 02'W 108.8 to the 336.7' to the point of beginning proper containing 1.27 acres, more or less.

IT IS THEREFORE, BY THE COURT CONSIDERED, ORDERED, ADJUDGED AND DECREED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and is in all things approved and confirmed, and that the proceedings before the court be and are hereby confirmed. The clerk of this court be and is hereby authorized to certify one copy of the plat of such annexed territory with one copy of this order of the County Court and resolution or ordinance of the City of Jonesboro, Arkansas, and forward copy of each to the Secretary of State who shall file and preserve the same and shall forward one copy of the plat of said annexed territory and one copy of this order to the Directory of the Tax Division of the Arkansas Public Services Commission who shall file and preserve the same and shall notify all utility companies having property in said municipality of this annexation of property, and the Clerk is directed to forward a certified copy of this order to the City of Jonesboro, Arkansas.
