

PETITION FOR REZONING

TO: THE CITY PLANNING COMMISSION OF THE CITY OF JONESBORO

The undersigned owners of property abutting on both sides of Haven Street in the City of Jonesboro, Arkansas, between Nettleton Avenue and Elm Avenue, presently zoned as residential property, R-2, hereby petition the City Planning Commission to rezone the said property for residential use under classification R-1. Petitioners state that the property is presently composed of single family residences, most of which are owned by elderly couples or widows and most of the occupants are retired from business. This area comprises a quiet residential neighborhood particularly suited to the needs of persons occupying and using the same as single family residences and that the highest and best use of said property is under classification R-1.

The undersigned are owners of property situated within the following area in the City of Jonesboro:

Lot 31 of Knight's Addition; Lots 1 to 10, inclusive, of Montague's Subdivision of Knight's Addition; Lots 1, 2 and 3 of Block 46 and Lots 1, 2 and 3 of Block 47 of Culberhouse's Subdivision; Lot 32 of Knight's Addition; Lots 1, 2, 3 and 4 in Block 41 of Wilson's Subdivision of Knight's Addition; Lots 3 and 4 of Claunch's Subdivision of Block 48 of Knight's Addition; Lots 1, 2, 3 and 4 of A.
