## **8. MAYOR'S REPORTS**

*Mayor Perrin reported on the following items:*

*Fire Station #4 is up and running. They will be putting disaster recovery equipment in there.*

*They were notified yesterday the City will be receiving \$100,000 from the Rockefeller Foundation. The City has been working on the grant for two years with the assistance of Councilman Coleman. He thanked Councilman Coleman for his hard work. The funding will go towards the North Jonesboro Initiative.*

*81 softball teams were present for a tournament at the Southside Softball Complex this past weekend. The gates and concession stand took in \$43,758 over the weekend.*

*He thanked the Jonesboro Police Department's bike patrol for riding around and speaking with the people around town. He received numerous compliments about that.*

*The YMCA pool renovation is on schedule. They are shooting for July 2nd completion.*

*A few years ago, Senator Bookout helped the City get a \$75,000 grant to set up a studio to make videos for Channel 24. The City received a Telly Award.*

*The bridge on Bridge Street will close on June 19th and be out until November. The*

*Matthews bridge is out and will be back open before school starts.*

*Bids for Barnhill Road improvements will go out this weekend. The road and shoulders will be widened. EDA grant funding will be used to make the improvements.*

*Mr. Jack Turner has worked on the City website and it is now able to be translated into different languages, such as Spanish or Chinese.*

*He met with Legislative Audit yesterday and the Council will be pleased with the audit. Councilwoman Williams will join him for the final interview when Legislative Audit comes back. He commended the Finance Department for their work.*

*Councilman Street reminded everyone of the Ward 4 meeting Thursday night, June 7, at 6:00 p.m. at the Earl Bell Community Center.*

*Councilman Johnson thanked the Mayor for the tour of the new public works facility. He commended the Mayor for his effort in getting the project done.*

*Councilman McCall asked for a status update regarding the portion of Matthews Avenue near the Marion Berry Overpass that is currently closed off. Mayor Perrin explained ASU is using Jacobs Engineering in Little Rock. They are redrawing the Matthews extension and needed additional right-of-way from the Country Club. Construction shouldn't take that long. They hope to have it open by the end of August.*

*Councilman Fears reminded everyone of the Bikers Classic that is starting this Thursday, June 7.*

*Councilman Gibson asked for an update concerning the double right-hand turn lane at Johnson Avenue and Highway 49. Mayor Perrin stated the Highway Department is in charge of that project, so he is unsure when it will be completed.*

*Councilwoman Williams discussed the Fisher Street railroad crossing. She noted it is very hazardous with no arms. She added there are spikes sticking up in the crossing. She stated that crossing will be used more when Bridge Street is closed. Dr. Coleman also stated city law says trains can only sit at an intersection for 15 minutes, but trains sit at that intersection a lot longer than 15 minutes. Mayor Perrin explained they have contacted the railroad companies concerning the length of time trains sit on the tracks and block intersections. He stated they will also talk with the railroads concerning the condition of the intersection.*

*Mayor Perrin referred to the Matthews Avenue question that was brought up earlier and added they have requested the landscaping be done on Caraway where the road is blocked off. Right now there are only concrete barriers and they would like to get the landscaping done. Councilman Moore then questioned who mows the grass on the north side of the tracks near Matthews and the tracks. Mayor Perrin answered it is his understanding it is the responsibility of ASU, but he asked for clarity from ASU because the grass got too high.*

*Councilman Coleman announced a presentation on June 13th at 11:00 a.m. to commend the supporters of the community gardens. He invited the Council to attend the presentation. He noted Councilman Moore donated a lot of work to put in water lines.*

## **10. PUBLIC COMMENTS**

*Ms. Amanda Vick, 6601 S. Caraway, discussed the community centers. She explained she has volunteered to coach volleyball for City Stars and Junior Olympics. She further explained she and her players have been harassed by some of the other players at the community center and has discussed the situation with Parks employee Brad Welbourne and Parks Director Wixson Huffstetler, who stated the situation would be taken care of. She then stated she recently got a call from the Parks Department telling her she would have to pay \$35 to play volleyball and put up a net at the community center because basketball is the dominate sport. She questioned who decided basketball is the dominate sport and why she has to pay to play volleyball. She added she was told there was no room for volleyball, but there is a volleyball court.*



*Mr. Huffstetler explained the community centers are open on a first come, first serve basis. He noted basketball is the dominate sport in the state of Arkansas and there are people waiting from opening until 3:30 every day to play on the basketball courts. He further explained they can't go in and ask those kids who have been waiting all day to leave so a volleyball net can be put up. He noted if a sport other than basketball is going to be played on the court, then reservations have to be made. He added the amount that is charged is a policy that was set by City Council long before he started working for the City. He stated Junior Olympic volleyball, as well as other associations, have reserved the gym to play there and they paid every time they used the courts.*

*Ms. Vicks explained she would like all kids to have a safe place to go. Councilman Woods asked if he could visit with her before she leaves the meeting.*

*Ms. Carol Ferguson, 1849 Green in Bono, stated she appreciates City Youth Ministries. She explained Ms. Vicks is her daughter and she has enjoyed watching the kids playing sports. She noted a lot of kids' parents don't have the money to reserve courts in order to play. She further discussed expanding the sports offers to kids in the City in order to give them any chance to play.*

*Councilman Johnson asked if there is a place in the community centers that can accommodate a volleyball court. He also suggested if there isn't a place at this time that when the YMCA building is renovated a court be made there. Mayor Perrin stated he will meet with Mr. Huffstetler and come back with information.*

*Councilman Gibson noted Ms. Vicks stated there are two basketball courts and one volleyball court set up in the facility. He questioned why the volleyball court isn't being utilized for volleyball. Mr. Huffstetler explained it is his understanding the net will extend from one side to the other on the courts, which will block other courts. He noted even when basketball is being played there is a curtain separating the courts so the players can have privacy on each side. Mayor Perrin added the YMCA building also has only one court.*

*Ms. Madison Hardin, 1762 CR 318, explained she is a volleyball player with Ms. Vicks and expressed concern about not being able to practice. She noted she can't play Junior Olympics, so Ms. Vicks is helping her get better at volleyball.*
