## ORDER OF ANNEXATION

On this <u>3677</u> day of <u>Muemper</u>, 1985, comes on for hearing before the court the petition for annexation of certain lands to the City of Jonesboro, Arkansas, filed in this Court on <u>Margen 23</u>, 1985. The petitioners appear by their attorney, Charles Frierson, III. The cause is heard upon the petition, notice of filing of said petition and of the date, time and place of hearing thereon, and the proof of publication of such notice as required by law, and the evidence introduced by the witnesses, argument of counsel, and all other matters and things before the Court, from all of which the Court finds:

That said petition is signed by the owners of a majority in number and acreage of the lands hereinafter described; that the owners of all of the property described in the petition are supportive of the annexation; that the notice of filing of said petition and the date, time and place of hearing upon said petition has been duly given and published as required by law; that all things required by law to be done have been duly and properly done; that the allegations of the petition are sustained by proof; that the requirements for signatures have been duly complied with; that the limits of the territory and lands to be annexed have been accurately described; and that an accurate plat thereof has been duly made and filed with this court; that the prayer of the petition is right and proper and that the land hereinafter described should be


