Mayor Perrin explained this property along with the one in RES-12:098 are currently under contract with Rob Merrell. He has purchased permits to do demolition.

Code Enforcement Officer Ronnie Shaver further explained that the properties were sold to Rob Merrell during the condemnation process. They have purchased the demolition permit and a rehabilitation permit. The properties will have to be brought back up to code. Mr. Shaver added they have spoken with Mr. Merrell and he knows he will have to start work on the properties. Councilman Coleman asked about the property owners getting an extension to do the work on the property. They are looking into recycling. Marck Industries offered an extension and will continue services a little while longer. The City is working with the Solid Waste Authority and Abilities Unlimited to look at the possibilities. They are going to look at other cities in order to do a cost analysis. He has met with Sanitation Director Royce

Leonard in order to receive cost estimates related to placing recycling containers around the City for citizens to use. The biggest cost of recycling is labor and fuel, but they are looking at the alternatives.

The City has collected \$1,267 so far this year with the ATM in the Justice Complex.

The parking lot on Cate and Union has been paved and striped.

He commended the Fire Department, Parks Department and JETS for their work with the recent hotel fire on Gee Street.

Richardson Road should be opened by August 20th before school starts.
